1. Call to Order

Chairman Vaughn Hartung called the meeting to order at 9:30 a.m.

2. Roll Call

3. Pledge of Allegiance

Commissioner Gibbons led a recital of the pledge.

4. Public Comment

Tony Clark, 24/7 Limousines, Manny Racinos, Limofi, Marin Popov, MP Limousine, David Andifer, Limofi, Donielle Faucett, PSS, and Damir Akmeyev, Sky Limo, questioned the insurance coverage requirements for carriers and differences between carriers and TNC's. Ash Demisse, Winner Limousine, stated there are gypsy operators using his fleet numbers, CPCN, and that his drivers are being threatened by the gypsy operators. He detailed his concerns and stated he has contacted his congressman. He also mentioned the differences in insurance coverage requirements and that he has had 3 or 4 drivers quit, go out and rent a car and run gypsy. Several others mentioned the differences in insurance coverage requirements between carriers and TNC's and the sophistication of the gypsy operators so they can avoid NTA enforcement. Drew Ribar, Reno, offered a statement regarding regulatory issues and NTA compliance with regulation.

8. Briefings from the Commissioners

Commissioner Groover offered congratulations to Adam Teti, who is going to the TA. Offered his congratulations to Paul Servello on his retirement and welcome Garrett Hammack. He also welcomed Amber Haggard to the Las Vegas staff. Chairman Hartung thanked Adam Teti for his service to the Agency and wished him luck in his new position. He requested Chief Foster develop a plan for the enforcement of gypsy operators. He also mentioned the golf tournament currently being held in Reno.

Brent Carson, Esq appeared on behalf of Mundi Vegas, LLC, and stated he did not agree with the Order as written and gave several reasons. Commissioner Groover questioned proper service and that there is a question who the actual Respondent is. Deputy Attorney General Kunnel stated the position that service to the correct Respondent was proper. Administrative Attorney Wilburn indicated the Hearing Officer felt the citations were issued to the wrong Respondent and in doing so, these citations could possibly be void. She indicated the Hearing Officer feels there is a missing party to the citations and that the request for an Order to Show Cause was to clarify the responsible parties. Chief Foster stated he was not clear if Enforcement had spoken to the drivers to determine who they worked for. Administrative Attorney Wilburn suggested tabling the Order to facilitate further investigation into ownership, the responsibility for the citations and possibly hold the application hearing after clarification. Deputy Attorney Kunnel suggested a rehearing of the citations. A discussion ensued with regard to resetting the hearing.
