1. Call to Order

Chairman Vaughn Hartung called the meeting to order at 9:31 am PST.

4. Public Comment -

Public Comment provided by Ms. Donielle Fawcett – Personal Sedan Services.

Ms. Fawcett commented that we have made progress in terms of illegal transportation work with the Commissioners and the Chief. She commented that the problem is out of control and is asking for a workshop to create a task force to get illegals off the street. A few are receiving citations today that operate companies – we ask that the NTA strengthen the fines. As legal companies, have large insurance premiums to pay. We had shared a video – an illegal driver ran over a flagger at convention center. An UBER driver approached a car and was shot yesterday. There is an obligation to provide safe transportation – not seeing that happen. Ms. Fawcett stated that she will not let her children out there. At Cowboy Christmas she saw the NTA but there are so many illegal drivers out there. We need more control and a larger group.

She is requesting a task force – the money received from citations - use that money for the task force. There are hundreds of people someone is going to get hurt. Need fines to be stricter.

DISCUSSION ITEM

42. Docket 24-10028 Discussion of report from certificated carrier regarding illegal passenger transportation. Continued from prior general session.

Comments:

Comment by Chairman Vaughn Hartung: Chairman Hartung stated that this is an ongoing item requested from Commissioner Groover.

Comment from Commissioner R. David Groover: I would like to hear from the industry associates as well as Chief Foster. I believe Deputy Commissioner Pasternak has been taking a more active role and I am not sure if he is ready to speak on this.

Public Comment provided by Ms. Donielle Fawcett – Personal Sedan Services.

Ms. Fawcett commented that this month had a busy month in the City of Las Vegas with Formula 1, the rodeo as well as Cowboy Christmas. She mentioned that there have been some kinks, too many out there – maybe thinking about doing a task force with temporary help to come down to do in a large scale. It is hard as a business owner to do the right thing – we have made mistakes along the way. *There are physical companies that run companies illegally – not one car but 10 to 15 cars under one* person. There is one person on the agenda who is on the agenda today and was given a deal who is an illegal operator running his business on Facebook, etc. There are multiple companies out there. I didn't realize impounding a car takes as long as it does or if there is a way to simplify that process. There has to be other options. For limo operators, forming an association to work through challenges we have with the Sphere, the Convention Center, Allegiant. I encourage all of you and am grateful other people are going out there and seeing the illegals out there with the investigation team. There are hundreds of illegals. They are evading taxes – payroll taxes, insurance, etc. I spend \$500,000 a year for car insurance, our payroll taxes, our 3% interest passenger carrier tax etc. Uber drivers at Cowboy Christmas go around on the backside and they don't even do Uber. Uber needs to be held accountable. They are handing out business cards. We need to educate the public, educating the properties, develop a long-term solution, a task force, etc. The Chief and I are working to get in front of Allegiant, the Sphere, etc. that have major issues that as operators and regulatory agencies, we are reviewing this and someone is going to get hurt. The traffic control people are charging \$50 to pull into the Convention Center and into the Sphere. I am telling my drivers to tell them no and tell them to tow the car. The Chief helped at the Convention Center and had a recording of the associate at the Convention Center requiring \$50. We are making strides in the right direction – working together as a group – we need to do a task force to make an impact. You will see on CES or at the Rodeo – there is another influx with California companies coming in. They are stealing state money when we have California companies coming into the State. Getting together outside of the Agenda and put together an open forum. I know it is not in the budget to hire more investigators – if we can get a sting where it is confidential and no one knows except the NTA and the task force where we can have 50 impounds in one day – need fresh faces all at once to get 50-60 and hold them accountable. Companies should not be able to operate in Nevada without a license.

Public Comment provided by Mr. Taju Seman – Silver State Limo

Mr. Seman commented that things are getting worse every day. He commented that there are illegals that own 4-5 vehicles without a license. We have individuals that worked for limo companies and now they have 2-3 cars to rent for other people. If there is anything we can do to help as an owner. This is very serious.

Comment provided by Commissioner R. David Groover:

I agree with her on getting a group together. A group or task force or a group of regulators, agencies. We have some assets — Taxicab is suffering the same issues with illegal drivers. The new board member at Taxi is a past member of the Stadium Authority Board and the Las Vegas

Convention Board, a former County Commissioner – Chief meet with Administrator Park and Taxicab Authority Member Dr. Lawrence Weekly he can open up doors for you.

There are a lot of people who can help us with this group. The contact at the at the Taxicab Authority can open doors for us.

Comment provided by Deputy Commissioner David Pasternak:

Both Chief Foster and I have been meeting with the Director's office and are creating a plan of action. We can put in the task force as one of them.

Comment provided by Chairman Vaughn Hartung:

Chairman Hartung provided a question to Ms. Kunnel. As long as we do not appoint the task force, they would not be subject to the Open Meeting Law?

Comment provided by Deputy Attorney General Radhika Kunnel:

It depends your Honor, we have to figure how it works. It all depends on the composition of the Task Force, if Commissioners are involved. Need to determine how it would work offline, how the operations would work, etc.

Comment provided by Commissioner R. David Groover:

I don't believe the Commissioners need to be on the task force. The Deputy Commissioner should be the beacon to lead the task force.

Comment provided by Chairman Vaughn Hartung:

I agree with that 100%. I don't believe we should be the ones to guide it. My recollection Ms. Kunnel – as long as Mr. Pasternak is allowed to put together an informal group they are not subject to open meeting law. My concern is that when this task force is put together, I do not want illegals as part of the task force. I was pleased with how Enforcement did during F1-13 total impounds – one was a rental car and he failed to appear at the hearing. We have \$20,000 in fines for impoundments; \$15,250 in fines to be adjudicate. We hear you loud and clear – in cases where they are repeat offenders, fines were substantial as well as the impounds. I do like the idea of the task force and getting other folks involved.

Need to look at legality of picking up passengers on private property. Not sure if under aiding and abetting. I am unsure, it is unclear to me.

Comment provided by Chief John Foster:

I would like to thank Danielle and Taju for spending time at the Agenda meeting to voice their

concerns. Danielle, the one flagger at the Sands, we sent Investigator Kim there and that individual was fired. Thank you for reaching out to us, we took care of that. At the Convention Center, there was an individual that road over someone's foot, we did take Enforcement action on him and impounded. The person's foot that was road over has not filed a police report at this time. Once that is filed, we will work in conjunction with LVMPD. Have that individual fully trespassed at the Convention Center- the individual that did this is a repeat offender. Our next contact with this individual is that he will be going to CCDC. As far as F1, it was an outstanding collaboration with all of the staff members. Thank you DC for getting us some overtime. We did team up with the Taxicab Authority and used a force multiplier to regulate illegal transportation.

As far as the resorts, I am in constant communication with the resorts and they know this is a crisis. I am in communication with the TNC's constantly as the drivers are handing out business cards. We have between 36,000-38,000 drivers. If we have a large group like that handing out business cards, we have a major issue.

We are running investigations on a lot of individuals. The Big Surge the NTA worked with SAS – we recovered 8 exploited children and arrested one individual. As we speak of task force, we do interact with other law enforcement agencies to help us with items such as facial recognition, etc. We are in the process of trying to get tools to pay for rides – right now it is all cash which has limited us in our scope.

Brokers are a problem. We are cracking down on brokering rides that they are not permitted to provide using NRS 706.756 to the best of our ability. Casinos state that they have trained their doormen. The casinos have put them on notice but they are still doing it.

Strip Clubs are a problem with kickbacks. It is a large animal to wrap your hands around.

It is a constantly changing business. We are working with B&I as the Deputy Commissioner stated. They are willing to allow us to get overtime for special events. Las Vegas Valley is doing a great job with having individuals coming here – can have three major events in the same day.

We are having Danielle set up a meeting with the Sphere, we are going to work that out with them. I stay up at night on ways to improve our efforts. We are hiring 5 new investigators from in state and out of state. I know it's not enough, but we are going to do the best we can with those 5 investigators.

We have a collaboration with the resorts – we are getting dispatched by Nevada State Police to the various resort locations. Security Staff at the resorts are dispatching to those locations. Word is out – we are hitting them – we are working to get better.

Comment provided by Commissioner R. David Groover:

Looks like we are making some progress which is the reason we are here.

Comment provided by Chairman Vaughn Hartung:

It is one bite at a time – it is too big to enumerate at any one time. This will be an ongoing item and will be on future agendas and work backwards on the task force.

Comment provided by Applications Manager, Elizabeth Babcock:

Ms. Babcock commented that the carrier has been operating for serval years and is owned by Jacob Price. Mr. Price is the recipient of government funds and all of their vehicles need to be ADA compliant. He contacted me for an RFP to continue these funds. He stated that they are not considering him as they felt they needed someone with TNC authority. The last time I spoke with Mr. Price, he stated that he had an appointment with them the next day. He has no operations going on yet, no drivers driving vehicles at this time. The transportation he does is through the rural areas of the state. If not operating – he could file a temporary discontinuance. Purpose of this is to get an update of where we stand – did they get the grant, are they operating, do they have vehicles, etc.

Comments provided by Commissioner Dawn Gibbons:

Commissioner Gibbons mentioned that there are a lot of things that are a problem. We are not sure of 7 livery vehicles – are they ADA compliant? This is my case – there are a lot of problems.

Comment provided by Chairman Vaughn Hartung:

A question for Ms. Babcock, given that this is a status check – do we recognize individually and then bring it back for action?

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

Not sure if anyone is online. The certificate they are operating on is an interim authority. From my point, I would suggest we have a hearing. This was issued in 2022. This company has chartered bus authority which they had at the time that they received the grant. They received temporary interim as it was determined the best thing to do at the time.

Comment provided by Commissioner Dawn Gibbons:

You did state that we are requesting a specific due date of 30 days or an order to show cause.

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

An order to show cause would result in a hearing unless Mr. Price can answer the questions now.

Comment provided by Commissioner Dawn Gibbons:

We need to know where the fleet of 7 vehicles are – there is so much we need to know. You have not kept up with us. We need to discuss the grant with us. Not sure what you are doing.

Comment provided by Jacob Price, owner of Western Trails Charters & Tours, LLC:

I have been in communication with Marta and Liz. We do have 7 vehicles inspected and up to date. This is a funded route though NDOT which did put it out to RFP. They asked for more an uber type of authority. We are asking NDOT if this is the type of authority that you would need – otherwise we would not need interim authority for rural inner city bus service. We are looking at State of Nevada, NDOT, to determine if this authority is good, and then obtain the RFP. If we don't then we would cancel the authority, if we do, then we will close it out. Marta had reached out for a few documents for final authority.

Comment provided by Commissioner Dawn Gibbons:

Commissioner Gibbons commented that Marta had a phone conversation on September 10, 2024 asking if compliance items are still needed. Mr. Price, we need more information – such as are the 7 vehicles ADA compliant.

Comment provided by Jacob Price:

Yes they are. They have all been inspected and we have paid for permits.

Comments provided by Commissioner Dawn Gibbons:

When do you think this will happen as I do understand that it will help the rural communities?

Comments provided by Chairman Vaughn Hartung:

Mr. Price, what we are asking is for a specific due date. Then the additional question for Ms. Kunnel – what are we styled to do today? It is for possible action – could we issue an Order to Show Cause?

Comment provided by Deputy Attorney General Radhika Kunnel:

Ms. Kunnel stated this is for possible action today. Can provide an Order to Show Cause.

Comments provided by Commissioner R. David Groover:

This has dragged on for years and far exceeded what interim authority it was supposed to be. I understand the recent stance with NDOT – if they want him to become an TNC – why does he want to finish this process. Think we need to bring them back for further discussion with NDOT to see what they are doing with that contract.

Comments by Chairman Vaughn Hartung:

As Mr. Price has already acknowledged that they do not comport as a TNC company as they do not have an APP. The driver has to own the vehicle. I do not see that it comports with those requirements.

Comment provided by Jacob Price, owner of Western Trails Charters & Tours, LLC:

Mr. Price provided additional information. NDOT has awarded the RFP to Greyhound Lines. Greyhound is negotiating the contract and is not authorized by the NTA. We were not awarded it. In limbo right now – not sure where it will land as Greyhound is not authorized by the NTA. I would ask for 30-60 days to provide the additional documents and/or make the determination on where we should go.

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

Ms. Babcock inquired if they are currently operating the 7 vehicles.

Comment provided by Jacob Price, owner of Western Trails Charters & Tours, LLC:

Mr. Price stated that we are not operating those vehicles under this authority. We have no customers on the line from Reno to Las Vegas.

Comment provided by Chairman Vaughn Hartung:

This whole thing started in March 2021 – just shy of 4 years – what is the appetite?

Comment provided by Commissioner R. David Groover:

It is a mess but need NDOT in these conversations – not sure this could be completed in 30 day time frame. I would recommend we push it out to 60 days and then bring it back.

Comment provided by Administrative Attorney Yoneet Wilburn:

Commissioners, may I ask a question. Why are we just not going to an application hearing on this and let them present? We are in the business where we want people to operate but we are going on 4 years. Just set the application hearing, bring in evidence, show us what they need to show us. That is just my suggestion.

Comment provided by Commissioner R. David Groover:

Also at the point he may be falling out of the contract. We can set an application hearing but this may resolve itself once we speak with NDOT but I'm amenable to either.

Comment provided by Chairman Vaughn Hartung:

Good suggestion.

Comment provided by Administrative Attorney Yoneet Wilburn:

Ms. Wilburn suggested setting it 45 days out for application hearing. This gives enough time to put all pieces in place.

Comment provided by Chairman Vaughn Hartung:

So sometime at the end of January. Does that work for you Mr. Price?

Comment provided by Jacob Price, owner of Western Trails Charters & Tours, LLC:

You bet.

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

If you are not operating on the seven vehicles, you will need to file a temporary discontinuance and the form is on the website.

Comment provided by Chairman Vaughn Hartung:

What is the timing of that? Would it be prior to application hearing?

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

That would be like today.

Comment provided by Jacob Price, owner of Western Trails Charters & Tours, LLC:

Mr. Price commented that we did speak with Ms. Babcock. We can run tomorrow but we have no passengers.

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

Ms. Babcock commented that if still available with drivers – then you would not need to file.

On this CPCN, we started out with temporary transfer with no intention of keeping this certificate due to the insurance company. If you own a bus and a limousine company, they will no longer separate the \$1.5 million from the \$5 million for a bus carrier. So they are requiring your entire fleet to have \$5 million insurance. We filed a separate docket under Landmark Transportation which was a charter bus CPCN. It was granted and approved by the NTA. Based upon that we would cancel this CPCN and run the buses through separate company. They still want to make everyone \$5

million USD because of the same address, etc. We went with Landmark for awhile getting that through the compliance items. The insurance company sent quotes of \$51,000 per year per bus. This meant we would stick with the LVL and keep it with the overall \$5 million as less expensive. I did file a sale and transfer – it has been late – 100% my fault that it is lingering. Request to extend the temporary interim authority pending the new sale and transfer.

Along with the illegal activities bring back discussion on insurance. Need to have a discussion on the insurance industry.

Ms. Babcock commented that she would appreciate if he withdrew the charter bus application and the temporary transfer of operating rights be extended during the process of the sale and transfer. I would just hope this moves quickly.

Comment provided by Mr. Jamie Kent, of James Kent Law:

Mr. Kent commented that he did represent a company that was an intervener in this matter. We were unilaterally removed a couple of months ago. But there are concerns related to the financials that we had that would have been up to date as we didn't receive anything different until a couple of months ago. My concern is that the NTA did look at this as they are certainly alarming to me. On their profit/loss of January 1, 2023- July 31, 2023, average income \$1.4 million but in July it dropped down to \$800,000. Why was there such a large drop? Their insurance dropped from \$39,000 to eventually \$2,000 in June and July. Why such a large drop when they state that their taxes are \$58,000 a month? Did anyone inquire if they are behind on their taxes. For balance sheets, these are large discrepancies and movements.

Comments were provided by differences in various categories were provided by Mr. Kent during a 6 month period. Did the NTA question why these operational numbers changed?

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

Ms. Babcock stated that we are not prepared to respond to particular line items without being informed in advance. One item that I do recall is that corrections were made in office furniture as they had gurney's in that account. Financial Analyst Garrett Hammack may be able to answer to those line items. We do look at backup.

Comment provided by Garrett Hammack, Financial Analyst:

I wouldn't speak to the exact numbers without seeing them on paper. We did an in depth analysis on the Pro Formas and the P&L to a level that I have not done on any other company. I am very confident in the financials.

Comment provided by Chairman Vaughn Hartung:

Mr. Hammack – There were some substantial differences with what Mr. Kent brought up. Are you ok with sale and transfer or should we table it?

Comment provided by Garrett Hammack, Financial Analyst:

Mr. Hammack stated that he is comfortable moving forward but if we wish to address some of those I could get some answers as well.

Comment provided by Commissioner R. David Groover:

If he says he is comfortable with it – I'm comfortable with it.

Comment provided by Commissioner Dawn Gibbons:

I'm fine with it.

Comment provided by Chairman Vaughn Hartung:

I'm taking your word that you looked at this. I have not delved deeply into the financials.

Comment provided by Commissioner R. David Groover:

And Chair, we all know the cost of fuel, maintenance has been erratic the past few years. It is impossible to predict.

Comment provided by Chairman Vaughn Hartung:

I'm comfortable moving forward as well.

Comment provided by Ms. Elizabeth Babcock, Applications Manager:

Ms. Babcock stated if Mr. Kent would give me the information, I can look at it. If there are any issues that come up from this, we can bring it back.

Comment provided by Mr. Brent Carson, Brent Carson LLC:

Mr. Carson stated that he objects to this. He had the opportunity during the application to be an intervener. He failed to present any evidence or any discovery. Now on the date of the hearing, he wants to introduce evidence after the staff has done a deep diver into the financials, not pro forma. We met every requirement as stated in paragraph number 4. Have 56% equity ratio – this is not time to bring new evidence now. He had this opportunity to do this previously. Staff supports application as is. A protest cannot come in here and introduce new evidence. They had their chance.

Comment provided by Commissioner R. David Groover:

Commissioner Groover commented that a PLTI was filed, absolutely nothing was done, it delayed the process, and it was dismissed.

Comment provided by Administrative Attorney Yoneet Wilburn:

Administrative Attorney Wilburn stated that the PLTI was granted in March 2023 or 2024 – I am not quite sure but there was a 6-month period where the PLTI was active. There was no discovery done, no discovery was requested and that is why and felt it was not appropriate as a PLTI as nothing was being done. It is Ms. Gibbons application, and she can make a motion to approve it and put it up for a vote.

Comment provided by Mr. Jamie Kent, of James Kent Law:

Mr. Kent commented that it was mentioned that the intervenor did nothing and the hearing was delayed. He stated that an intervenor it is not required to do any discovery. The intervenor was granted authority and based upon the application was made and to have standing. There was a hearing to remove the intervenor because he did not do any discovery and that was denied. There was no discussion to have the discovery by a deadline, no discussion – unilaterally removed. The delay was not us. We did not thing to delay this. Ms. Main commented that the general timeframe for applicants is 1 year. If it is beyond 1 year – will request a second set of prints. Since the operations have not started, new prints would be the requirement.

How long does it take to get fingerprint background check? That could be a problem.

She couldn't call in before – petition for reconsideration of dismissed application – with or without prejudice?

Comment provided by Ms. Yoneet Wilburn, Administrative Attorney:

Ms. Wilburn commented that is should be without prejudice.

Is it better to start over again?

Can we put a shelf life on this or is it expeditious to start over again?
