MINUTES OF OCTOBER 9, 2025, GENERAL SESSION

1. Call to Order

Chairman Vaughn Hartung called the Meeting to order at 9:32 am PST.

2. Roll Call

3. Pledge of Allegiance

Commissioner Louis Csoka led the Pledge of Allegiance.

4. Public Comment

Edward Davis, Frank White & Associates, LLC, commented on the status of insurance prices for the transportation industry.

Edric Tong expressed concerns regarding driver and vehicle safety.

Rick Duffield expressed concerns regarding the effects of tunnels on the taxi industry.

Walter D. Amaya expressed concerns over rising insurance prices for the transportation industry.

Mark Kramer expressed concern regarding vehicle congestion.

Ouida Burnett echoed the previous comment regarding vehicle congestion and expressed concern about the effect of new transportation options on taxi drivers' livelihoods.

Gary Dickson commented in opposition to Paradise Transportation Company's application for a CPCN.

7. Briefings from the Commissioners

Chairman Vaughn Hartung welcomed Commissioner Louis Csoka to the Board and thanked Commissioner Dawn Gibbons for her service to the NTA. Chairman Hartung also recounted his experience at the International Association of Transportation Regulators (IATR) conference and announced that Las Vegas was selected to be the site of the 2026 IATR conference.

Commissioner Adam Teti thanked Commissioner Dawn Gibbons for her service and welcomed Commissioner Louis Csoka to the Commission. Commissioner Teti also welcomed Deputy Commissioner Todd Park and thanked him and NTA Staff for their work during the State's server shutdown.

Commissioner Louis Csoka thanked Chairman Vaughn Hartung and Commissioner Adam Teti for their welcome, and thanked the Office of the Governor and the Director's Office for the appointment to the Board. Commissioner Csoka also echoed the thanks given to NTA Staff and to Commissioner Dawn Gibbons, and finally thanked his colleagues at the Nevada Attorney General's Office for their work and service to the State.

8. Briefing from the Deputy Commissioner

Deputy Commissioner Todd Park thanked Director Kristopher Sanchez for the opportunity to work with the NTA, and Staff for their work to overcome the obstacles presented by the State's server shutdown. Deputy Commissioner Park also introduced the Agency's new Chief of Enforcement, Dominic Del Padre, and asked him to introduce himself.

Chief of Enforcement Dominic Del Padre introduced himself and expressed gratitude for inheriting eager Enforcement Staff.

9. Report of Legal Counsel

Deputy Attorney General Radhika Kunnel shared an update on the legal matters involving the NTA; in the Jenkins matter, the Petition for Judicial Review was dismissed. There was no word of an appeal and

the deadline to file an appeal also passed. In the Lifetrans matter, the Petition for Judicial Review was also dismissed, an appeal was filed, and the NTA is awaiting their briefing. Deputy Attorney General Kunnel also congratulated Commissioner Csoka on his appointment and thanked him for his service with the Attorney General's Office.

Administrative Attorney Yoneet Wilburn thanked Commissioner Dawn Gibbons for her service to the NTA and welcomed Commissioner Louis Csoka to his new role. She also clarified for the audience that Commissioner Csoka would be recusing himself from votes on matters which he worked on as a Senior Deputy Attorney General, and the remaining Commissioners would vote on those items. Votes on such matters must be unanimous in order to approve any item; in the case of a split vote, the item does not get approved.

Commissioner Adam Teti expressed his concern about wording in items 104, 105, 118, 119, 120, 121, and 122 which stated that there would be fines for future violations of NAC 706A.240(2), given his understanding that the NTA could impose penalties in the form of removal from a TNC platform, not fines.

Commissioner Louis Csoka commented that he was not involved in the adjudication of the matters which Commissioner Adam Teti expressed concern about and suggested that the Board take a vote on the remaining Citation matters and that he would be able to provide his input on the items that would be pulled out of the block vote.

Commissioner Csoka explained for items 104, 105, 118, 119, 120, 121, and 122 that these were matters which were prosecuted by Deputy Attorney General Radhika Kunnel and therefore they did not present a conflict of interest which would require him to recuse himself. With regard to the legal question of whether a fine can be imposed for violations of NAC 706A.240(2), Commissioner Csoka explained that the remedy available with relation to drivers is either a warning, a finding of a violation without a fine, or disqualification of a driver in the event of repeat violations. Monetary fines as remedies against drivers are not available under NAC 706A. Therefore, Commissioner Csoka expressed his opinion that the orders needed to be amended to remove language about monetary fines.

Chairman Vaughn Hartung disclosed that he had a phone conversation with Attorney Brent Carson, who has filed a protest on this docket, and while the Chairman offered no comments, opinions or conclusions

on the phone call, he recused himself from the item in an abundance of caution in order to avoid any possible appearance of impropriety. He asked Commissioner Teti to assume the role of Chairman for the discussion on this item and run the meeting.

Commissioner Csoka expressed his intention to participate in the discussion on this docket item, given his limited involvement in matters related to the item, namely providing his opinion that the applicant did need to apply for a license with the NTA. Besides that involvement, Commissioner Csoka had no other involvement on the matter.

Deputy Attorney General Radhika Kunnel agreed with Commissioner Csoka's characterization of his involvement on the matter and her opinion that no conflict of interest is presented by Commissioner Csoka's participation in this discussion on this docket item.

Administrative Attorney Yoneet Wilburn expressed the same conclusion as Deputy Attorney General Radhika Kunnel. Administrative Attorney Wilburn stated that she believed, with reference to the NTA's regulatory framework, that this matter is properly regulated by the NTA and not the Taxicab Authority, as was suggested at a recent meeting of the Taxicab Authority.

Ashley Steinberg and Tyler Fairbanks were present to represent Paradise Transportation Company and fielded questions from the Commissioners.

Financial Analyst Garrett Hammack summarized Paradise Transportation Company's Application information and the investigation done by the NTA, and indicated that the NTA supports Paradise's Application.

Brian Hardy, Esq., spoke in opposition to Chairman Vaughn Hartung's decision to recuse himself from the matter, as he felt it deprived the public of the opportunity to petition their elected official.

Chairman Adam Teti asked Paradise Transportation Company whether they would consider a waiver to allow Chairman Vaughn Hartung back to the Board for the discussion on this item. Ashley Steinberg responded that she would be open to a waiver.

The applicant, Paradise Transportation Company, gave a waiver allowing Chairman Vaughn Hartung to return to the Board for the matter. Additionally, Attorney Brent Carson withdrew his Petition for Leave to Intervene from consideration so there would be no potential conflict of interest in Chairman Hartung ruling on the matter. Chairman Hartung reversed his recusal and rejoined the Board.

The Commissioners asked further questions of Tyler Fairbanks and Ashley Steinberg of Paradise Transportation Company relating to operation of rides and the specifics of the proposal by the applicant.

The Board discussed whether Attorney Kimberly Maxson-Rushton's Protest and Renewed Petition for Leave to Intervene was a protest or petition for leave to intervene for the purposes of the discussion at the Agenda, given that the latter categorization would require further noticing in order to discuss it at the Agenda.

Vote taken to treat the Protest and Renewed Petition for Leave to Intervene filed by Attorney Kimberly Maxson-Rushton as a protest for the purposes of the October 9, 2025 General Session Meeting's proceedings:

Item 153 Motion made by Commissioner Csoka Seconded by Chairman Hartung Approved 3-0 Ed Finger, Chief Strategy Officer of the Las Vegas Convention Visitors Authority commented in support of Paradise Transportation Company's application, citing the necessity of further options and optimization for the Vegas Strip corridor.

Mariano Locascio spoke in opposition to Paradise Transportation Company's application, specifically with regards to the proposed per-capita pricing on rides.

Paul Adams, a driver for Yellow-Checker-Star Taxi Company, spoke in opposition to the application, believing the proposal would hurt taxi companies and drivers.

Michael Bailin, General Manager of Taxi Management, spoke in opposition to the application due to the effect he believed it will have on taxi drivers.

Melanie Rogers, a driver for Yellow Cab, spoke in opposition of Paradise Transportation Company's application.

Athena Eliades, a member of the Board of Directors for Taxi Management, spoke in opposition of Paradise Transportation Company's application, stating her belief that they should instead be regulated through the Taxicab Authority and have to apply for a medallion.

Armentha Ceasar, a driver for Yellow-Checker-Star Taxi Company, spoke in opposition to the application due to her belief that taxi companies cannot compete with the prices being offered by the applicant.

Alan Waxler, AWG Ambassador, spoke in opposition to the application because he believes the applicant is encroaching on existing businesses' markets.

Jose Bonifaz, a driver for Yellow-Checker-Star Taxi Company, commented in opposition to the application due to the effects on taxi drivers its approval would have.

Juan Beltran commented in opposition to the application due to his belief that there would be no incentive for the applicant to complete the tunnels if approved.

Attorney Kimberly Maxson-Rushton spoke in opposition to the application, specifically stating that her clients should be recognized as a party to the matter as intervenors, that a market for the applicant has not been demonstrated, that there has been no demonstration of safety on the project, and that there is a lack of financial solvency for the applicant. Additionally, Ms. Maxson-Rushton asserted that the authority sought by the applicant is improper for the types of transportation they are seeking to provide.

Attorney James Kent spoke in opposition to the application and denial of Ms. Maxson-Rushton's Petition for Leave to Intervene. Mr. Kent spoke about aspects of the application which he felt were lacking in substance and should lead to denial of the application. Additionally, Mr. Kent stated that the order should not allow an unlimited amount of vehicles for the applicant, which it showed as drafted.

Attorney Brent Carson spoke in opposition to the application, specifically opining that moving forward on the application may be a violation of Open Meeting Law due to the breadth of redaction in the publicly available version of the application.

Attorney Patricia Erickson spoke in opposition to the denial of the Petition for Leave to Intervene, as she stated the legal jurisprudence relied upon in the order denying the Petition for Leave to Intervene was not applicable, as substantially different facts apply in the case of that precedent.

Tyler Fairbanks, Paradise Transportation Company, commented in response to several of the points raised during public comments on the application, specifically addressing the type of authority the applicant is seeking, safety on the project, progress on approval of airport service, and operations on a trip-to-trip basis.

Ashley Steinberg, Paradise Transportation Company, additionally commented on the safety of the project, and the applicant's market being demonstrated.

The Board asked clarifying questions of the representatives from Paradise Transportation Company regarding the company's plans and intentions in utilizing a Certificate of Public Convenience and Necessity.

Chairman Vaughn Hartung expressed a discomfort with granting a blanket approval to the application, instead hoping to condition the approval in some way, perhaps by requiring certain milestones to be reached within a certain timeframe with respect to the applicant's proposed tunnel system.

Commissioner Louis Csoka clarified with Attorney Yoneet Wilburn that the application was initially only necessary due to the vehicles exiting the Vegas Loop tunnels in order to access the airport, and that the NTA would not have any jurisdiction over the transportation that occurs solely within the tunnels. Chairman Vaughn Hartung expressed concern over the scope of proposed order, which he felt could authorize transit outside that scope.

Commissioner Adam Teti similarly expressed a willingness to condition the approval on construction milestones being completed within a certain timeframe, and expressed concern over the unlimited vehicle fleet size in the proposed order as well as the seemingly unlimited distance of above-ground transport allowed on each trip.

Tyler Fairbanks, Paradise Transportation Company, expressed a willingness to comply with conditions on approval of their application such as a timeline of construction milestones.

The Board discussed what changes they would make to the proposed order, relating to vehicle fleet size, distance travelled outside of the tunnels, and construction milestones they would like to see the applicant meet on their overall proposal. Administrative Attorney Yoneet Wilburn recommended against putting specific milestones for construction of the tunnels due to the condition being overly restrictive. The Board considered putting a timeframe on the Certificate of Public Convenience and Necessity within which the applicant would need to come back before the full Authority for a status check.

Vote taken to approve with the following modifications to the draft compliance order; the applicant will be limited to 102 vehicles in their fleet until such time as the applicant applies for an expansion; status checks will be conducted every six (6) months to assess whether the applicant is exhibiting best efforts to complete their tunnel project—with those held at the two (2) and five (5) year marks to be held in front of the Full Authority—and the Certificate of Public Convenience and Necessity will be subject to revocation at the five year mark if best efforts have not been made; and each ride will be subject to a four (4) mile maximum of above-ground transit:
