COMPLIANCE ORDER

The Nevada Transportation Authority ("Authority") makes the following findings of fact and conclusions of law:

1. That on July 7, 2025, Kaptyn Nevada, LLC d/b/a Kaptyn, Presidential Limousine ("Seller" or "Kaptyn") and Echo Nevada, LLC d/b/a Kaptyn Transportation, Presidential Limousine ("Buyer" or "Echo") filed a joint Application for the Seller to sell and transfer and the Buyer to purchase and acquire the authority to provide charter limousine, airport transfer, special services, and charter bus service in the State of Nevada, granted under CPCN 1040, Sub 5; CPCN 2063, Sub 2; CPCN 1007, Sub 8; CPCN 2119, Sub 4. Said Applications designated as docket 25-07007, 25-07008, 25-07009, and 25-07010, respectively.
2. That the Applications were properly noticed to the public and no Petitions for Leave to Intervene or Protests were filed.
3. That on July 30, 2025, an amendment to the application was filed for Exhibit R to clarify

the DBAs and how Echo will mark its vehicles.

4. That Staff requested the application hearing be dispensed, pursuant to NRS 706.391(9).

Commissioner Adam Teti, serving as Presiding Officer for the Authority, granted the request.

5. That Authority Staff reported the following:

- a. Chris Greten, Compliance Audit Investigator, completed the background investigation and supports the applications in all aspects except for the fact that the criminal background has not been received for all persons submitted.
- b. Garrett Hammack, Financial Analyst, inspected the Transferee-Applicant's financial information and supported approval of the Application.
- c. Liz Babcock, Application Manager, supports this application in all aspects except for the fact that the criminal background report has not been received. However, this is addressed through compliance.

6. Based upon all the records pertaining to the Applications, and pursuant to NRS 706.6411:

- a. The Authority has considered the service which has been performed by the Transferor-Applicant and that which may be performed by the transferee;
- b. The Authority has considered the other authorized facilities for transportation in the territory for which the transfer is sought;
- c. The Transferee-Applicant is fit, willing, and able to perform the services of a common motor carrier by vehicle, and the proposed operation would be consistent with the legislative policy set forth in NRS 706.151; and
- d. The public interest requires no additional amendments, restrictions or modifications be attached to the Certificate.

Therefore, based upon the foregoing findings, it is ORDERED that:

1. The Application on file herein shall be GRANTED for the transportation service specified

below:

CPCN 1040, Sub 5

On-Call irregular route transportation of passengers and their baggage in charter limousine service, special services, and airport transfer service using Traditional and Livery Limousines between points and places within Clark County, Nevada and Counties contiguous thereto.

Restrictions: Special service transportation shall be provided for a minimum of twelve (12) persons per special services contract.

CPCN 2063, Sub 2

Operate as a passenger carrier to provide intrastate charter bus service, airport transfer service, and special services within the State of Nevada

RESTRICTION: Special service transportation shall be provided for a minimum of twelve (12) persons per special services contract.

CPCN 1007, SUB 8

On-call irregular route charter limousine service between points and places in Clark County, Nevada.

Special services transportation of passengers who have acquired the exclusive use of a vehicle at a per capita rate.

CPCN 2119, Sub 4

Operate as a passenger carrier to provide intrastate charter bus service between points and places within the State of Nevada.

2. Upon full compliance with the conditions of this Order, the four (4) Certificates of Public Convenience and Necessity identified as CPCN 1040, Sub 5; CPCN 2063, Sub 2; CPCN 1007, Sub 8; CPCN 2119, Sub 4, shall be CANCELLED, and four (4) new Certificates of Public Convenience and Necessity authorizing operation in charter limousine, airport transfer, special services, and charter bus transportation as is more particularly described hereinabove, shall be issued as follows:

- a. CPCN 1040, Sub 6 and 2063, Sub 3 to Echo Nevada, LLC d/b/a Kaptyn, and
 - b. CPCN 1007, Sub 9 and 2119, Sub 5 to Echo Nevada, LLC d/b/a Presidential Limousine,
3. Before issuance of the Certificate referred to hereinabove, the Applicant shall be required to:
- a. Avoid material changes in any conditions relied upon by the Authority in its determination of operational or financial fitness and immediately report to Authority Staff any such material changes, should they occur. (Form provided by NTA)
 - b. File with the Authority evidence of the required insurance (Form E) in the Applicant's name in accordance with NAC 706.193.
 - c. File with the Authority the necessary insurance (Certificate of Insurance and Schedule of Autos) describing the liability limits and vehicles covered in accordance with NAC 706.191.
 - d. Make vehicles available for inspection by Authority Staff to ensure that they properly display the CPCN number, name of the company, and other required markings in accordance with NAC 706.170. Provide copies of insurance cab card, annual (USDOT) vehicle inspections, titles, and registrations. All documents must reflect the approved motor carrier name.
 - e. Ensure all drivers have applied for driver's permits.
 - f. Ensure driver qualification files are setup in accordance with CFR 391.51. Explain and make available set up of time tracking method put into place. Ensure all drivers have pre-employment drug testing in accordance with CFR 382.301.
 - g. Ensure vehicle maintenance files are setup in accordance with CFR 396.
 - h. File copies of carrier's Charter Orders for review by Authority Staff, which includes the CPCN numbers granted.
 - i. File tariffs for review by the Financial Analyst, which includes a description of the authority granted, CPCN numbers, the motor carrier name, d/b/a, name and title of the issuing officer, and address.
 - j. Provide a copy of the contract between Applicant and the laboratory that will perform and monitor the substance abuse program.

- k. Results of the fingerprints for Hassan El-Lahham, John Ferrari, Trevor Halleran Contetra Blackmon, George Mbulo Jr. and J.J. Bell are received with no areas of concern noted.
 - l. Provide proof that the payment to seller due at closing was paid.
 - m. Provide proof that the required capital infusion was made into the Echo Nevada, LLC company bank account.
 - n. Remit to the Authority any noticing fees and/or other outstanding debt to the Authority.
4. Compliance with the foregoing requirements must be made NO LATER THAN one hundred and twenty (120) days after issuance of this Order. If the Applicant fails to comply within one hundred and twenty (120) days after issuance of this Order, the Deputy Commissioner may vacate this Order and dismiss this Application.
5. This Order does not constitute operating authority. Performance of the transportation service contemplated by this Order may not be instituted prior to the issuance of said Certificate referred to hereinabove.
6. If the carrier is cited by the Authority for any violation of NRS 706 prior to the close of the compliance period, the Deputy Commissioner shall vacate this Order and dismiss the Application unless the Authority orders otherwise.
7. The Deputy Commissioner shall be authorized to issue the above-referenced Certificate of Public Convenience and Necessity upon the Applicant meeting all requirements set forth herein.
