**NOTICE OF APPLICATIONS and REQUESTS FOR TARIFF MODIFICATIONS FOR  
THE F1 SPECIAL EVENT**

Vegas VIP Transportation, LLC., dba Vegas VIP Limousine filed an application, designated as Docket No. 23-09010-A, with the Nevada Transportation Authority (Authority) requesting a temporary expansion of its fleet by 65 vehicles for its charter limousine authority, and approval of a tariff modification, granted under Certificate of Public Convenience and Necessity (CPCN) 1095, Sub 1. The requested expansion will occur between November 12, 2023 and November 22, 2023 for the sole purpose of providing transportation during the F1 Special Event.

Earth Limousine, LLC., dba Earth Limos filed an application, designated as Docket No. 23-09010-H, with the Authority requesting a temporary expansion of its fleet by 6 vehicles for its charter limousine authority, and approval of a tariff modification, granted under Certificate of Public Convenience and Necessity (CPCN) 1108. The requested expansion will occur between November 12, 2023 and November 22, 2023 for the sole purpose of providing transportation during the F1 Special Event.

Omni Limousine, Inc. has filed a request, designated as Docket 23-09010-C, with the Authority for approval of a tariff modification regarding its charter limousine service provided

pursuant to CPCN 1084, Sub 5. This requested tariff modification will be solely for the F1 Special Event from November 12, 2023 to November 22, 2023.

AWG Ambassador, LLC. has filed a request, designated as Docket 23-09010-E, with the Authority for approval of a tariff rate modification regarding its charter limousine service provided pursuant to CPCN 1041, Sub 7. This requested tariff modification will be solely for the F1 Special Event from November 12, 2023 to November 22, 2023.

Western Limousine Service, LLC. has filed a request, designated as Docket 23-09010-F, with the Authority for approval of a tariff rate modification regarding its charter limousine service provided pursuant to CPCN 1054, Sub 3. This requested tariff modification will be solely for the F1 Special Event from November 12, 2023 to November 22, 2023.

Abraham Limo Service, Inc. has filed a request, designated as Docket 23-09010-G, with the Authority for approval of a tariff rate modification regarding its charter limousine service provided pursuant to CPCN 1090, Sub 2. This requested tariff modification will be solely for the F1 Special Event from November 12, 2023 to November 22, 2023.

The applications and tariff modification requests were filed pursuant to Chapter 706 of the NRS and the Nevada Administrative Code (“NAC”). Under NRS 706.151, the Authority has legal jurisdiction and authority over these matters.
