10 APPLICATION OF TARIFF:

30 LIABILITY:

Maximum Daily Charge (17 thru 24 hours)	1,045.29	860.50

RATES FOR HIGHER CAPACITY COACHES:

Rates for coaches with additional seating capacity will be based on the rates for a 47 passenger coach converted into a per seat charge and then multiplied by the capacity requested.

Capacities generally available are 49, 52, 55, 58 and 59 seats.

Example: A request for a five (5) hour minimum charter for a 58 passenger coach on May 5 would be calculated as follows:

$$\$449.30 \text{ divided by } 47 = 9.559 \times 58 = \$554.42$$
