CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

The Nevada Transportation Authority ("Authority") finds that the above-named carrier has complied with this Authority's Amended Interim Compliance Order dated April 20, 2023, the findings of fact and conclusions of law which are hereby incorporated by this reference, and therefore is entitled to receive authority from this Authority to engage in transportation in intrastate commerce as a motor carrier.

IT IS ORDERED that certificate of public convenience and necessity identified as CPCN 1143, is hereby cancelled and Reno Medical Transport, LLC d/b/a GMTCARE is hereby granted this certificate of public convenience and necessity, identified as CPCN 1143, Sub 1, as evidence of the authority of the holder to engage in transportation in intrastate commerce as a common carrier by motor vehicle subject to applicable statutes, rules and regulations of the Authority, and such terms, conditions and limitations as are now or may hereafter be attached to the exercise of the privileges herein granted.

IT IS FURTHER ORDERED and made a condition of this certificate that the holder shall render reasonably continuous and adequate service to the public in pursuance of the authority herein granted, and that failure to do so shall constitute sufficient grounds for suspension, modification or revocation of this certificate.

IT IS FURTHER ORDERED that nothing contained herein shall be construed to be either a franchise or irrevocable and that failure to comply with rules, regulations and orders of the Authority and applicable statutory provisions shall constitute sufficient grounds for suspension or revocation of this certificate.

IT IS FURTHER ORDERED that this authority shall not be sold or transferred without the Authority's prior approval.

IT IS FURTHER ORDERED that the transportation service to be performed by said carrier shall be as specified below:

Non-emergency medical transportation of passengers to and from medical facilities, limited to ten (10) vehicles, within the counties of Washoe, Storey, Douglas, and Churchill and the city and county of Carson City, subject to the following limitations at Applicant's request:

- a. No administration of any medical service during any transport;
- b. No employee providing the transports may hold any state-approved medical certificate; and
- c. No administration of medical equipment to patients during transports, with the exception of low-flow oxygen tanks, consistent with Nevada statutes and regulations.

The NTA does not have a role in enforcing the provisional limitations as stated above which shall be strictly enforced between the parties.

The NTA will be held harmless for any potential liability and/or damages occurring from any passenger that may be injured during transportation of such services.

IT IS FURTHER ORDERED that the Authority retains jurisdiction for the purpose of correcting any errors which may have occurred in the drafting or issuance of this Order and Certificate of Public Convenience and Necessity.
