**APPLICATION OF TARIFF:**

#1 Rules, regulations, rates and charges named in this tariff apply to the transportation of passengers and their baggage and light express in taxicab service between points and places within an area encompassing Elko county, Eureka County, Lander County, White Pine County, that portion of Humboldt County east of, and including, Golconda, Nevada and 50 miles south of Golconda, Nevada into Pershing County, Nevada, and between points and places within Elko county, Eureka County, Lander County, White Pine County, that portion of Humboldt County east of, and including, Golconda, Nevada and 50 miles south of Golconda, Nevada into Pershing County, Nevada on the one hand, and points and places within the state of Nevada on the other hand.

**COMPUTATION OF RATES AND CHARGES:**

#2 Rates and charges named in this tariff are applicable to waiting time, deadhead, delivery and live service.

**ANIMALS:**

#3 Dogs, cats, or other live animals will not be carried unless properly confined in an approved container.  
**Exception:** Seeing-eye dogs in the performance of their duty guiding blind persons.

**OBJECTIONABLE PERSONS:**

#4 Carrier reserves the right to refuse transportation to any person under the influence of intoxicants, drugs, or incapable of taking care of himself, or when conduct is likely to be objectionable. This rule does not apply to persons who are ill and are accompanied by an attendant or nurse.

**OTHER RIGHTS OF REFUSAL FOR TRANSPORT**

- #5 Carrier reserves the right to refuse transportation to any person:
- a) carrying sharp objects that may damage the interior of the vehicle or become a danger to the driver or other passengers.
  - b) carrying excessive valuables such as jewelry or cash.
  - c) carrying a weapon.

**FLAMMABLES**

- #6 No explosives, flammables, or liquids which could contaminate or be harmful to passengers or vehicles will be carried.

**CARRIER'S LIABILITY**

- #7 Carrier will not be liable for loss or damage to passenger's belongings unless occasioned by lack of reasonable care on carrier's part, and then only for the reasonable value thereof, with a maximum liability of \$100.00 per single piece of luggage or proven value of other items.

**CLAIMS**

- #8
1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.
  2. Within 14 days after receipt of claim, the carrier shall:
    - a) Compensate shipper or consignor; or
    - b) Deliver to shipper or consignor a written denial of the claim.
  3. A denial of a claim may be appealed by the shipper or consignor to the Commission.

**RAILROAD CREWS**

- #9
- When a request for transporting railroad crews of the Union Pacific or Southern Pacific Railroads from or between points outside of Elko County is made to Elko Taxi Service, Inc., the dispatcher or other employee of the carrier shall inquire whether such request for service has been previously made to Brown's Crew Car of Wyoming, Inc., d/b/a Armadillo Express ("Armadillo"). If the railroad has not contacted Armadillo, Elko Taxi Service, Inc. shall ask the railroad to do so to determine whether Armadillo has the equipment needed to provide the service requested. If the carrier determines that the request for the move was previously made to Armadillo and that Armadillo could not provide the requested service, then Elko Taxi Service, Inc. shall proceed to provide the service requested.

**RATES AND CHARGES**

**A. FOR TRANSPORTATION SERVICES OF PASSENGERS AND THEIR BAGGAGE:**

**Meter Rates:** \$3.25 per initial pickup and 25¢ for each 1/11<sup>th</sup> mile.

**Wait Time:** 50¢ per minute.

**Senior Discount:** Above charge minus \$1.25. Senior discount applies to transportation services only and **DOES NOT** include deliveries.

**Surcharge:** Dispatcher will notify customers of outside of Elko City Limits surcharge and obtain their approval before dispatching taxi.

**B. AGREEMENT**

Customers with established credit accounts that have a minimum of 15 trips within 30 consecutive days, each having 75 or more total miles and that originate and terminate within Elko city limits will receive a discount of 38% with billing terms of 5/30 net 45.

**For example:**

\$1000 Less 38% discount = \$620

\$620 less 5% discount = \$589 due if paid within 30 days or \$620 due in 45 days

**C. Casino Shuttle Service:** Provide shuttle service for Players Club Members. Shuttle to service those Players Club Members who request shuttle service to or from Casino property from which the Players Club Card has been issued and within a 3 mile radius of that property. Casino to pay \$25.00 per hour for Driver and Vehicle. Players Club Member to pay \$6.00 per pick-up or drop-off.
