LIABILITY

LV Tours will not be liable for any personal items brought onto the vehicle. Lost or stolen items will not be the responsibility of LV Tours.

SMOKING POLICY

No smoking will be allowed on any LV Tours vehicle.

DRUG POLICY

No drugs may be carried or used on any LV Tours vehicle.

CANCELATIONS

Cancelations made by the customer must be made 72 hours in advance to receive a refund, otherwise cancellation rates as outlined in these rules and regulations will apply.

OBJECTIONABLE PERSONS

The driver of the transit vehicle will have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly, or who is believed to be under the influence of narcotics.

ANIMALS

Animals other than "seeing eye" dogs, will not be carried.

CHILDREN UNACCOMPANIED

No person under the age of 18 years old will be permitted to take part in service unless a parent, guardian or other responsible adult accompanies the minor. An adult will be defined as any person who is over 18 years of age or older and who is ultimately responsible for the care and supervision of the child.

NON-DISCRIMINATING

Carrier will not refuse service to anyone because of race, creed, sex, or national origin.

SEAT BELTS

All passengers will be required to fasten the provided seat belts at any time the vehicle is moving. Carrier reserves the right to refuse service to any person who cannot or will not wear a seat belt.

RULES & REGULATIONS

APPLICATION ON TARIFF

Carrier operates special service transportation company, over irregular routes using commercial vehicles to provide intrastate passenger transportation in the form of special service from points and place within Clark and Nye counties, Nevada on the one hand and the state of Nevada on the Other.

COMPUTATION OF RATES AND CHARGES

Rates and charges are identified herein and pertain specifically for custom tours on an hourly basis consistent with the authorized authority as granted by the Nevada Transportation Authority and per capita charges for special services.

BAGGAGE

- a) Hand baggage shall not exceed forty (40) pounds per each bag per adult passenger.
- b) Articles with sharp edges will not be carried unless securely and safely packaged.
- c) Explosives, inflammables, or harmful liquids will not be transported.

LIABILITY

Pursuant to NAC 706.333, a claim by a shipper or consignor against a common motor carrier for a lost or damaged freight or baggage must be submitted to the carrier within seven (7) days after the loss or damage is discovered. Thereafter, within 14 days after receipt of the claim, the carrier shall either (a) compensate the shipper or consignor; or (b) deliver to the shipper or consignor a written denial of the claim. A denial of the claim may be appealed by the shipper or consignor to the NTA. Carrier will not be liable for loss or damage to baggage or their contents unless such loss or damage is caused by lack of responsible care and then only for the reasonable value thereof, subject to a maximum liability to \$250.00 for the Loss of, or damage, to any single piece of baggage, including contents.

LIMIT OF LIABILITY

Carrier will not be liable for delays caused by an act of god, public enemies, authority of law. Quarantine, riots, strikes, accidents, breakdowns, highway conditions, or any other condition beyond its control and does not guarantee arrival or departure time from any given point at any specified time. However, the carrier will endeavor to maintain the schedule submitted by the contracting party but the same is not guaranteed. If in the opinion of the carrier, an act of god, public enemies, authority of law, quarantine, riots, strikes, accidents, breakdowns, highway conditions, or any other condition beyond its control, makes it inadvisable to operate its equipment from the point of origin or any point enroute, the carrier shall not be liable therefore or be caused to be held for damages for any reasons whatsoever. LV TOURS LLC will not be held liable or responsible for personal articles lost, stolen from passengers, or left in the equipment vehicle.

3% TAX Pursuant to SECTION 51 of AB175

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
