CHARTER SERVICE TARIFF I

**RULES AND REGULATIONS**

---

**1. APPLICATION OF TARIFF**

Fares and charges named in this tariff are stated in gross (commissionable) terms; and cover only ground transportation of passengers and their baggage, as provided in Carrier's Operating Authority in transportation operations. Rates and charges provided in this tariff, for services as ordered, shall be prepaid or paid by established accounts within 30 days of service. Charges for services in addition to the services ordered and previously prepaid shall be paid within 48 hours of presentation of invoice or transportation bill to the debtor.

---

**2. NON-DISCRIMINATION**

Carrier will not refuse service to anyone because of race, creed, sex or national origin.

---

**3. BAGGAGE & CLAIM PROCEDURE**

Hand baggage, not to exceed fifty (50) pounds in weight for each fare ticket will be carried without charge. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of reasonable care on its part and then only for the maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage, including its contents. Claims for loss of baggage must be communicated to the carrier at the time the passenger arrives at his/her final destination. Carrier will not settle claims on the spot in any circumstances. The passenger will have 7 days to submit a supporting written claim which must contain sufficient information regarding such loss. The carrier shall have a reasonable time in which to locate baggage before making settlement, which will not be more fourteen (14) days after being notified of such loss. Within fourteen (14) days after receipt of the written claim with supporting documents, the carrier shall (a) compensate the passenger or (b) deliver the passenger a written denial of the claim. A denial of a claim may be appealed to the Nevada Transportation Authority. (NAC 706.333)

---

**4. CHILDREN – UNACCOMPANIED**

No person under the age of 18 will be permitted to charter a vehicle. Anyone under the age of 18 will require a parent, guardian or other responsible adult to accompany the minor or will require a minor's liability agreement which is signed and given to the driver for each minor. In addition, in the case all minors are under the age of 15 they will be permitted to participate in the services provided that an adult is present. We define an adult as any person who is 18 years of age, or older who is responsible for the care and supervision of the minor during the Charter. If any persons under the age of 21 is caught possessing or consuming alcohol or drugs during a charter, the charter will be terminated immediately. Minor's parents or guardians will be required to come and pick the minors up at the location terminated, or the minors will be returned to the parent or guardians pick up location, or authorities will be contacted depending on circumstances, and no monies will be refunded from the Charter.

## 5. OBJECTIONABLE PERSONS

The driver of the vehicle will have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly, engaging in violent behavior, being destructive of carriers' property, displaying or wielding a firearm, is believed to be under the influence of narcotics, or is believed to present a danger to the health or safety of the driver.

## 6. CARRIER'S LIABILITY

The Carrier will not be liable for delays caused by an act of God, public enemy, authority of law, quarantine, pandemic, riots, strikes, force majeure, accidents, breakdowns, unnavigable conditions of the road, storms and other conditions beyond its control; and does not guarantee to arrive at or depart from any point of specified time. The Carrier will endeavor to maintain the schedule submitted by its agent or employee; and, over routes indicated, but the same is not guaranteed.

In the event any of the above conditions exist and, in the opinion of the Carrier, it is inadvisable to operate its equipment from the point of origin to any point in route. The Carrier shall not be liable therefore or be held for damages for any reason whatsoever.

## 7. EQUIPMENT SUBSTITUTION

When scheduled equipment is not available, due to breakdowns, airport delays or early arrivals, or due to an increase in the total number of passengers, carrier may at their discretion substitute equipment.

## 8. SEAT BELTS

Seatbelts will be available for passengers and it is at their discretion as to usage.

---

## 9. SMOKING POLICY

Smoking of any kind, but not limited to cigarettes, cigars, medical and recreational marijuana etc. will not be permitted in any of the carrier's vehicles.

## 10. ANIMALS

Animals, other than ADA (Americans with Disabilities ACT) Service Animals will not be carried unless properly confined.

A special cleaning fee (actual cost) will be assessed to the passenger(s) for damages caused by pets or animals.

## 11. CANCELLATION FEE AND REFUNDS

All monies are due before the execution of the transportation. Cancellations must be made a minimum of 72 hours prior to the scheduled date/time of the transportation to receive a full refund. (During Special Events this cancellation period is extended to 14 days) Cancellations made within the 72-hour window (14-day window for Special Events) will forfeit 50%. Same Day Cancellations and No Shows will forfeit 100%.

## 12. VEHICLE DEFINITIONS

1. **Perimeter Seating Limo Bus**- maximum passenger capacity of 16, including driver.
2. **Perimeter Seating Limo Bus**- passenger capacity of 17-20, including driver.
3. **Perimeter Seating Limo Bus or Stretch Ford F-650**- passenger capacity of 21-26, including driver.
4. **Perimeter Seating Limo Bus**- passenger capacity of 27-30, including driver.
5. **Perimeter Seating Limo Bus**- passenger capacity of 31-36, including driver.
6. **Perimeter Seating Limo Bus**- passenger capacity of 37-46, including driver.

## 13. CHARTER SERVICES RATES AND CHARGES

**“Kelly Rates”** - Applies where customers do not pre-arrange for transportation via company telephone or internet but by other sources where there are no marketing expenses involved. Rate includes driver & audio equipment.

**“Office Charters”** - Applies where customer pre-arranges transportation via company telephone or internet. Rate includes driver & audio equipment.

**“Point to Point Charters”** – Applies for transfers with a duration of less than 30 Minutes taking place along the Resort Corridor of Las Vegas Boulevard

**Rates and Charges** named in this Tariff are applicable to “dead head time”. Dead head time is when the vehicle is without passengers and the customers point of origin or point of destination is more that fifteen (15) miles from base. For calculation purposes, the base is McCarran International Airport.

**Holidays & Special Event** - transportation provided in conjunction with any holiday or events deemed by the Las Vegas Convention & Visitor Authority to have an estimated visitor count of 20,000 people or more and includes Homecomings, Proms, NASCAR, Electric Daisy Carnival, National Finals Rodeo, Consumer Electronics Show, and New Year's Eve.

## 14. COMPUTATION OF RATES AND CHARGES

- Limousine Amenities Hourly Add Ons: (All Vehicles Except 31-36 Passenger Limo Bus and 37-45 Passenger Limo Bus) Following will be a cost of \$10.00 per hour. Specifically Requested Music, Lighting Show, Bluetooth Connection, Wi-Fi Connection, Audio visual Access, and Corporate Branding in vehicle.
- Limousine Amenities Hourly Add Ons: (31-36 Passenger Limo Bus and 37-45 Passenger Limo Bus) Following will be a cost of \$15.00 per hour. Specifically Requested Music, Lighting Show, Bluetooth Connection, Wi-Fi Connection, Audio visual Access, and Corporate Branding in vehicle.
- A \$5.00 per hour charge will apply if clients require usage of HDMI Cables, Phone Chargers, or other connection items. (Applies to all Vehicle Types)
- Special Events Surcharge: will be at a cost of \$25 per hour added to the associated hourly rate. (Reference Rule #13)
- Specially requested Amenities, including but not limited to publications, flowers, decorations, and balloons etc.,
  - o Travel of 20 miles or more to obtain items: \$100.00 plus actual cost of items
  - o Travel of 11-19 miles to obtain items: \$75.00 plus actual cost of items
  - o Travel of 3-10 miles to obtain items: \$50.00 per trip plus the actual cost of requested items
  - o Travel of up to 2 miles to obtain items... cost will be \$25.00 per trip plus actual cost of requested items.
- Bottled Water will be provided at a cost of \$10.00 per case
- Additional Ice will be provided upon request for \$5.00 per bag
- For vehicles equipped with bathroom: Bathroom will not be accessible unless passengers agree to additional \$250.00 Fee plus \$25.00 per hour upcharge to cover necessary sanitation and cleaning required after utilization.
- An airport fee of \$15.00 will apply on all airport arrival charters (AVI fee) for vehicles with a passenger capacity of 19 or less; \$20.00 for vehicles with a passenger capacity from 20-31; \$30.00 for vehicles with passenger capacities of 32 or more.
- One Time Covid Cleaning Fee -will be applied to all reservations based on the passenger capacity breakdown below. If clients specifically request for vehicle to be sanitized in their presence prior to the start of their charter the price will be doubled. Breakdown is as follows:
  - o Vehicles holding 1-20 Passengers - \$10.00
  - o Vehicles holding 21-30 Passengers - \$15.00
  - o Vehicles holding more than 31 Passengers - \$20.00
- Meet and greet fee of \$15.00 will be added for all airport arrivals requiring driver to meet passengers in baggage claim. An additional \$10.00 will be charged for a personalized sign.
- Rate is exclusive of rates for accompanying staff (Interpreter services, VIP Host, or Concierge Services)
- Out of town charters (Charters operating outside of a 50-mile radius of Harry Reid International Airport) may be subject to an additional \$30.00 per charter hour for added mileage, and maintenance expenses.
- Any toll charges, parking, park entrance fees, or other trip fees are the responsibilities of the customer.
- The maximum driving hours per day allowed by law is 12 hours. Any long-distance trip over 6 hours driving one way requires overnight stay at turning point, making the trip two days. A per diem of \$200.00 per night will be charged in lieu of driver lodging and meal expenses.
- The discounts given will be as follows: a 5% discount will be given for all Repeat Clients - 10% discount is given when a customer reserves simultaneously two (2) separate 1-hour minimum charters for transportation. Both hours must be reserved at the original time of booking - a 10% discount will be given for any continuous charters lasting 2 hours or more - a 10% discount will be given to Affiliates, Military, and all Essential Workers. Discounts can be used in conjunction for a total of 35%.
- Hourly Minimums will be required for certain Special Events- i.e., Prom/Homecoming (4-6) Hours, Las Vegas Motor Speedway Events (2-3) Hours, CES Convention (10-12) Hours, Sam Boyd Events (2) Hours, etc...

### 15. PASSENGER AGENT

Carrier may select to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively, desire to obtain passenger transportation service between one or more common points for the collection of all applicable charges and remittance thereof direct to carrier without individual passenger fare collection by the carrier.

---

### 16. COMMISSIONS OR REFERRAL FEE

Carrier may pay a commission or referral fee to a travel agent, a broker, tour operator, corporate contracted client, or other persons who arrange for the provision of transportation by the carrier to a third party, so long as the commission or referral fee does not exceed 20% of the applicable rate or charge specified in this tariff.

---

### 17. CONTINUOUS CHARTER PROVISION

When customers request transportation requiring dropping off and then picking up again within 60 minutes of the drop off time for further service, the trip will be considered as one continuous charter and customer will be charged for the interim waiting time. Charter services will only be provided over paved, maintained roadways.

---

### 18. DAMAGE AND SPECIAL CLEANING

Each vehicle dispatched for a charter will be in good condition upon arrival. Any damage to the vehicle which is caused by intentional acts or negligence of the passenger(s) will be charged by the carrier to the customer(s) as follows:

**19. FUEL SURCHARGE**

**Fuel Cost Price Adjustment (Surcharge)**

The following Fuel-Related Cost Price Adjustment (Surcharge) will apply on passenger transportation charges, as described below:

1. On the 25th day of each calendar month, the price per gallon of gasoline will be determined based on the price stated by the U.S. Department of Energy (DOE), Energy Information Administration's (EIA) survey on "Retail On-highway Gasoline Prices - West Coast Average". This price will be obtained by calling the DOE Fuel Hotline at (202) 586-6966 or via the DOE Internet website at [www.eia.doe.gov](http://www.eia.doe.gov)
2. If the 25th day of the calendar month is a federal holiday, the price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the fuel price adjustment factor matrix set forth in this item to determine the Fuel Cost Price Adjustment that will become applicable on the 1st day of the following month and will remain in effect through the last day of that calendar month.
4. The surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.
