**RULES AND REGULATIONS****APPLICATION OF TARIFF**

Rules, regulations, rates and charges named in this tariff apply to the transportation of passengers and their baggage in the charter limousine service. All transportation must originate or terminate within Clark County, Nevada.

**BAGGAGE**

- a) No tools or articles with sharp edges will be carried unless securely and safely packaged.
- b) No explosives, flammables, or liquids that could contaminate or be harmful to passengers will be carried.

**ANIMALS**

Dogs, cats or other live animals will not be carried unless properly confined in an approved carrier. **EXCEPTION:** seeing-eye dogs in the performance of their duty.

**APPLICATION OF RATES AND CHARGES**

Rates and charges named in this tariff are applicable to live service.

**OBJECTIONABLE PERSONS**

Carrier reserves the right to refuse transportation to any person under the influence of intoxicants or drugs or incapable of taking care of himself or herself, or whose conduct is likely to be objectionable to other passengers or prospective passengers. **EXCEPTION:** Incapacitated or ill persons accompanied by a nurse or guardian.

Carriers will not be liable for loss or damage to the contents thereof unless occasioned by lack of responsible care on its part, and only for the reasonable value thereof, subject to a maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage including its contents.

**CLAIMS**

Claims for loss or damage to baggage must be submitted to the carrier within seven (7) days after the loss or damage is discovered. Within fourteen (14) days after receipt of the claim, the carrier shall: compensate the claimant or deliver to the claimant a written denial of the claim. A denial of the claim may be appealed by the claimant to the Nevada Transportation Authority.

**FUEL SURCHARGE TABLE AND RULES**

The following Gasoline Fuel-Related Cost Price Adjustment (Surcharge) will apply on Charter Limousine Service Charges, as described below.

- a. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective on the 25<sup>th</sup> calendar day of the immediate preceding month, determined according to the United States Department of Energy, (DOE). Energy Information Administration's (EIA) survey on Weekly Retail Gasoline and Diesel Prices, (PADD 5). The prices may be obtained by calling the DOE, EIA at (202)586-8800 or via the DOE, EIA website at [www.eia.doe.gov](http://www.eia.doe.gov) via the "Petroleum" Link.
- b. If the 25<sup>th</sup> day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
- c. The DOE fuel price obtain will then be indexed based on the price matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all Bus transportation beginning on the 1<sup>st</sup> day of the following month and will remain in effect through the last day of that calendar month.
- d. The fuel surcharge will be added on hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

When the DOE Fuel Price Per Gallon reported on the 25 <sup>th</sup> of the month is:	The Fuel Surcharge that becomes effective on the 1 <sup>st</sup> day of the following month is:

Note 1: The fuel surcharge that is applicable for a given month must be passed along to all customers.

Note 2: The fuel cost adjustment will be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.

**3% TAX Pursuant to NRS 372B.150**

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

**Pursuant to Nevada NRS 372B.150**

1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. The excise tax collected by the Department pursuant to subsection 1 must be deposited with the State Treasurer in accordance with the provisions of NRS 372B.170.

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
