APPLICATION OF TARIFF

Rule No. 5

The charges published in this tariff apply to the account of Starlight Limousine, inc. For the following transportation services as provided for in the carrier's Certificate of Public Convenience and Necessity.

"Carrier operates an on-call commercial transportation company, over irregular routes using a charter bus to provide intrastate passenger transportation in the form of charter bus service from points and places within the State of Nevada."

APPLICATION OF RATES AND CHARGES

Rule No. 10

All charges herein are shown in dollars and cents and are payable in lawful United States money.

The charges published in this tariff are based upon the total number of charter minibus/ bus and/or coaches necessary to transport the charter party, plus extra accommodations. If the total number of passengers exceeds the capacity of one charter vehicle, the charges shown herein will be applied separately to each charter vehicle used. Charges shown herein apply to charter trips over paved, oiled macadam roads, and roads over which the charter vehicle can operate at the time of the trip with safety and without undue wear.

Las Vegas Strip Corridor is defined as "Hotels and Casinos located on both sides (east and west) of Las Vegas Blvd starting at Russell Road on the south and ending at Stewart Ave to the north, All the Casino / Hotels Bearing L.V Blvd Address.

Charges named herein do not include driver gratuities and can be added upon chartering parties' permission as a stated amount and/or percent of the charter rate.

Charges for transportation and other arrangements are due and payable as specified on each Charter Service Confirmation unless specific arrangements are made during bookings to warrant an exception.

Charges named herein include the service of the vehicle and the driver unless otherwise stated.

Hours of service defined: Intrastate Bus driver shall not drive longer than 10 hours and twelve consecutive hours on duty. Driver must be off duty for 8 hours before resuming driving as mandated by NTA (NAC 706.3612).

The carrier will abide by all State and/or Federal Safety Standards mandated for Safe Passenger Service.
Credit Cards are acceptable and will be subject to an additional fee of 3% of the total charges.

ANIMALS

Rule No. 20

Animals, other than "Guide Dogs" or other animals that assist a person with disabilities, will not be carried without prior arrangements and approval from the carrier. Approval requires any animal to be properly confined.

LIMIT OF BAGGAGE LIABILITY

Rule No. 25

The carrier assumes no responsibility for any personal carry-on baggage. That Baggage will not be checked. Any electronics, small and/or large i.e. (Computers hardware and software, Mobile devices, Any and all handheld devices, etc.) but not limited to, must be in the passenger's personal care. We will not be responsible for any loss to the equipment and/or its contents hereof. No tools with sharp edges may be carried. Personal baggage, musical instruments, athletic equipment, and other paraphernalia necessary for the purpose of the trip, limited to the capacity of the charter minibus/ bus/coach, will be transported in the custody of the charter party at no additional charge. Under no circumstances will explosives, inflammables or liquids which could contaminate or be harmful to passengers, driver or equipment be carried. Weapons of any kind are not allowed for the safety of all involved in and outside the vehicles. There is a limit of two bags (40) LBS each, per passenger without additional handling charge and limited to the capacity of charter vehicle. Additional handling fee is noted on page 8, subparagraph 6 (h).

LIMIT OF LIABILITY

Rule No. 35

The Carrier will not be liable for delays caused by an Act of God, Public Enemies, Authority of Law, Quarantine, Riots, Strikes, Accidents, Breakdowns, Highway Conditions, or any other condition beyond its control and does not guarantee arrival or departure time from any given point at any specified time. However, the carrier will endeavor to maintain the schedule submitted by its agent and/or employee but the same is not guaranteed.

Carrier will not be liable for loss or damage to baggage or their contents, unless such loss or damage is caused by lack of reasonable care on its part and then only for the reasonable value thereof, subject to a maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage, including its verifiable contents.

If in the opinion of the carrier, an Act of God, Public Enemies, Authority of Law, Quarantine, Riots, Strikes, Accidents, Breakdowns, Highway Conditions, or any other condition and beyond our control, makes it inadvisable to operate our equipment either from the point of origin or any point en-route, the carrier shall not be liable therefore, or be caused to be held for damages for any reasons whatsoever.

CLAIMS

Rule No. 40

1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage submitted in writing to the carrier within seven (7) days after the loss or damage is discovered.
2. Within 14 days after receipt of the claim, the carrier shall:
 - a. Compensate the shipper or consignor; or
 - b. Deliver to the shipper or consignor a written denial of the claim.
 - c. A denial of a claim may be appealed by the shipper or consignor to the Nevada Transportation Authority.

OBJECTIONABLE PERSONS

Rule No. 45

The carrier will refuse to carry or will remove, at any proper point en route, any person who is intoxicated or believed to be under the influence of narcotics. The carrier will also refuse to carry a passenger whose physical or mental behavior, is such, as renders him or her incapable of caring for himself or herself without assistance or render him or herself objectionable to other passengers or is involved in any hazard or risk to other persons or property being transported. EXCEPTION: This rule does not apply to persons who are ill and are accompanied by an attendant or nurse.

CANCELATION OF SERVICE FOR VEHICLE TYPE "A-G"

Rule No. 50

The carrier reserves the right to cancel any service because of weather or other conditions such as road hazards due to slides, storms, or any other similar causes, natural or otherwise, which make travel inadvisable. The carrier will charge fifty (\$50) dollars, cancellation fee in the event the request for service is canceled less than forty-eight (48) hours of the requested service date. Cancellation with less than twenty-four (24) hours' notice or on the spot and/or after arrival will be charged the full amount of the charter order. Carrier requires a 7-day cancellation notice for all holidays and/or during special events as noted under rule 292 subparagraphs two and will require a 50% non-refundable deposit on all bookings in addition to "Standard cancellation policy rules as noted above". This Cancellation policy applies to vehicles "A-G" only. Coach(H) bus service cancellation policy is noted on Page 13.

Children-Unaccompanied

Rule No. 55

No person under the age of eighteen will be permitted to take part in service unless a parent, guardian or other responsible adult accompanies the minor. We define an adult as any person who is over the age of eighteen or older and is responsible for the care and supervision of a minor.

CHILDREN'S FARE

Rule 60

No child will have a reduced rate. No child will be allowed to sit on anyone's lap. Children who require infant seats or child safety seats will be allowed on the provision that a responsible adult provides such a seat and installs it in the vehicles securing it with vehicle safety belts.

NON-SMOKING (All Type & Kinds)

Rule 62

All vehicles are designated as "Non-Smoking" of any kind.

EQUIPMENT SUBSTITUTION

Rule No. 65

The carrier may at their discretion substitute equipment when scheduled equipment is not available, or there is an increase or a decrease in the total number of passengers. The carrier will make every effort to accomplish that task in a timely manner as circumstances warrant. A substitute vehicle will also be provided within a reasonable time in case of service failure.

AGENT Rule No. 70

Carrier may elect to appoint as its agent any organization, firm, corporation, broker, tour operator, hotel, motel, casino, and/or other legal gaming operation that individually or collectively desires to obtain passengers bus transportation service between one or more common points for collection of all applicable charges and remittance thereof directly to the carrier without individual passenger fare collection by the carrier. Carrier may extend a fee of 10% of the applicable charges to such an agent as a commission or referral fee for their participation. A 12% discount will be extended to all other licensed Bus, Coach, and/or Limousine Companies regardless of usage in good faith as Agent Fee Participant.

COMPUTATION OF CHARGES

Rule No. 292

Charges will be computed as provided in the subparagraph noted below of this rule for each vehicle category.

1. BASE CHARGES FOR VEHICLE TYPE (A-G) (PAGES 9-10). The charges shown on the following pages are for charter and/or on-call and/or Walk-on bus service. All service charges cover continuous transportation, as well as when the vehicle is rented and/or reserved but not moving and/or occupied by passengers, preventing use by other prospective clients. A standard charge is a Minimum of 1 hour and 30-minute increments thereafter for the Vehicles category (A-G). All Airport pick-up service for Vehicle types (A-G) will be a minimum of 1.5 hours plus all other fees noted on page 8, Rule 725. The minimum service charge for a vehicle category (H) is listed below in subparagraph (6).

2. FEDERAL HOLIDAYS AND SPECIAL EVENT CHARGES FOR VEHICLES TYPE (A-G) Page 9-10:

All federal holidays are a minimum of 3- hours. For special Events i.e., CES, a minimum of 10 hours or 3 hours minimum for pick/drop service, NASCAR, Formula One 10 hours minimum or 4-hours minimum for pick/drop service, EDC, 10 hours minimum or 3 hours minimum for pick/Drop service. Proms/homecomings/school dances are 4 hours minimum, New Year's minimum 10 hours or 4 hours minimum for pick/drop service, NFR 10 hours minimum or 4 hours minimum for pick/drop service, Weddings, birthdays, and bachelor parties will be a minimum of 3-hours. Raiders & Oakland A's will have a minimum of 6 hours for pick/drop service.

Additional service hours will be billed at (1) hour increments (instead of half-hour increments as noted in Rule 292 .1) after the minimum service charge for this subparagraph (2) services only.

3. WEEKEND RATES FOR VEHICLE (A-G) DEFINED Page 9-10. There will be special rates for the weekend only, as noted on Page 9 for vehicle categories A-G. Weekend time starts on Friday at 12 Noon and ends on Sunday at 3:59 AM.

4. VEHICLE CATEGORY (H) COACH BASE CHARGE(Pages 11-12): The base charge to be assessed will be either the Time charge computed under the provisions of subparagraph six or the Live Mileage charge computed under the provisions of subparagraph five whichever is greater.

The charges computed under the provisions of subparagraph seven (7) of this Rule will be assessed in addition to the base charge.

5. VEHICLE CATEGORY (H) COACH LIVE MILEAGE (Pages 13): The Live Mileage charge provided in Rule No. 1500 will be assessed for each mile traveled by the charter coach between the point of origin and the point of destination plus any dead-head charge as noted in No.7.

6. VEHICLE CATEGORY (H) COACH TIME CHARGES (Pages 11-12): The time charges provided for in Rule No. 1000 will be assessed for each 24-hour period, computed from the time the charter coach is ordered to be at the point of origin, to the time the coach is vacated by the charter party at the point of destination, subject to a minimum charge of 3 hours (57 passenger motor coach), 2 hours for (45 passenger coach) plus any dead-head charge as noted in No.7 if applicable.

7: VEHICLE CATEGORY (H) DEAD-HEAD MILEAGE CHARGE (Pages 11-12-13): There will an additional service charge of eight (8) hours to the charter bus cost when a Coach must travel more than 175 miles, to pick up and/or drop off passengers and travel up and/or back empty to the base in addition to all other applicable costs. Hours of service rule is noted on page 4 rule 10, as mandated by state and/or federal authorities and strictly applies in this case as well.

8. CLARK COUNTY PASSENGER FEE: Any charter service that includes a pick-up at the airport will have an additional charge per entry, per vehicle, which will be added to all other applicable charges. (Current fee is \$10 as required by Clark County).

FRACTIONS, DISPOSITION OF

Rule No. 365

In computing charges or distances, all fractions must be retained at their full value until the final result is obtained then all remaining fractions will be disposed of in the following manner:

1. Fractions of less than one-half cent or mile, OMIT.
2. Fractions of more than one-half cent or mile increase to the next whole cent or mile.
3. Fraction of a quarter-hour shall be rounded.

ADDITIONAL SERVICE CHARGES

Rule No. 725

1. All National Parks and State Parks, any amusement parks assessing coach entrance fees, all parking fees, any and all road and/or bridge tolls, overnight coach parking fees, airport parking fees, and driver(s) room and board, while out-of-town will be the responsibility of the chartering party or added beforehand or during the trip, with the permission from chartering party.
2. Carrier may arrange on the charter party's behalf for their rooms, food, and other activities as requested. The cost of the accommodation will be added to all other charges including room and board for the driver(s) if specified, while out-of-town with their express permission.
3. Any additional mileage operated, or time incurred by the carrier occasioned by an Act of God, bad conditions of the roads, or any other circumstances beyond its control, will be charged at the applicable rate.
4. Any additional time incurred by the carrier at the request of the charter party beyond the originally scheduled charter will be charged at the applicable rate.
5. All costs for additional drivers or drivers required by reason of the use of the charter equipment in such a manner that the original driver must be released from duty to comply with applicable federal or state hours of service regulations (Page 4-rule10), will be identified and added to all other charges. We may also substitute the vehicle to comply with this law.
6. Additional Service Charges will be added as noted below where applicable.
 - a. On-site coordinator requested by the client to organize/ facilitate passenger transfer is \$30/hour with a 3-hour minimum.
 - b. Guest assistance service will be \$10 per occurrence, where the carrier meets passengers inside the baggage terminal to assist.
 - c. Gate meet fee will be \$50 per occurrence where guest request meets and assist them at the arrival gate inside the terminal.
 - e. Cleaning of vehicles -\$500 when a vehicle is left excessively dirty/messy including vomit but not limited to equipment damage above normal wear and tear.
 - f. Water/Soda/Ice: \$50/day (25 Bottles) and all other amenities at cost plus a \$20 handling fee. (All amenities are based on availability. Some amenity items will require advance arrangements.
 - g. Cigarette Burns \$500, Broken/missing decanters \$50, Broken/missing glasses \$10, Smoking of all kinds, is prohibitive, violation fee is \$100 per occurrence, ripped seating \$ 500, broken windows \$1000 and/or any physical damage at cost.
 - h. Baggage handling fee is \$20 per trip upon arrival/departure when luggage exceeds more than 2 (40 lbs.) bags per passenger.

Sec. 36 Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection one does not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours, or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare. defined above.

The LIMOZ app automatically calculates the rate for each trip requested in the app based on the origin and end points selected by the passenger/user, including the estimated time to travel between the two points, and any current road conditions as reported to the app by integrated third party GPS and traffic information systems. The app also makes use of an integrated technology to establish concentric service corridors that are used to calculate hourly service rates. The corridors defined in the LIMOZ app are as follows and as illustrated in **EXHIBIT 1** hereto:

- **Corridor 0 (Strip Corridor):** The interior of the shape defined by Sunset Blvd. to the south, Decatur Blvd. to the west, Bonanza Rd. to the north, and Maryland Parkway to the east. It includes Harry Reid International Airport.
- **Corridor 1:** Interior is limited by Corridor 0; Exterior is defined by straight lines between the intersections at Rainbow Blvd./Tropicana Ave. to the west, Carey Ave./Las Vegas Blvd. to the north, Sandhill Rd./Tropicana Ave. to the east, and Silverado Ranch Blvd./Las Vegas Blvd. to the south.
- **Corridor 2:** Interior is limited by Corridor 1; Exterior is defined by straight lines between the intersections at Volunteer Blvd./Las Vegas Blvd. to the south, Highway 215/Summerlin Pkwy to the west, W. Washburn Rd./N. Decatur Blvd. to the north, and N. Pacific Ave./E. Horizon Dr. to the east.
- **Corridor 3:** Interior is limited by Corridor 2; Exterior is defined by straight lines between the intersections at Highway 95 N/Nu Wav Kaiv Blvd. to the north, Red Rock Canyon Rd. (Hwy 159)/Scenic Loop Rd. to the west, Goodsprings Rd. (Hwy 161)/Las Vegas Blvd. to the south, and Highway 93/Lakeshore Rd., Boulder City, to the east.

Rates and Charges named in this Tariff includes the following additional fees as well as a Deadhead Time Charge.

- **Application of rates and charges** starts when the customer gets in the vehicle or the time a reservation for the service was scheduled whichever comes first and ends when the vehicle arrives at a destination where the passenger disembarks from the vehicle and informs the driver, they no longer require use of the vehicle, for immediate ride request the charges starts when the vehicle arrives at the pickup location.
- **Cancellation Fee:** Applied if the ride is canceled 5 minutes after the request is confirmed in the app. Cancellation fees for e-hailed rides through the LIMOZ app will be equal to ¼ of the hourly rate for the type of vehicle that was requested and then cancelled.

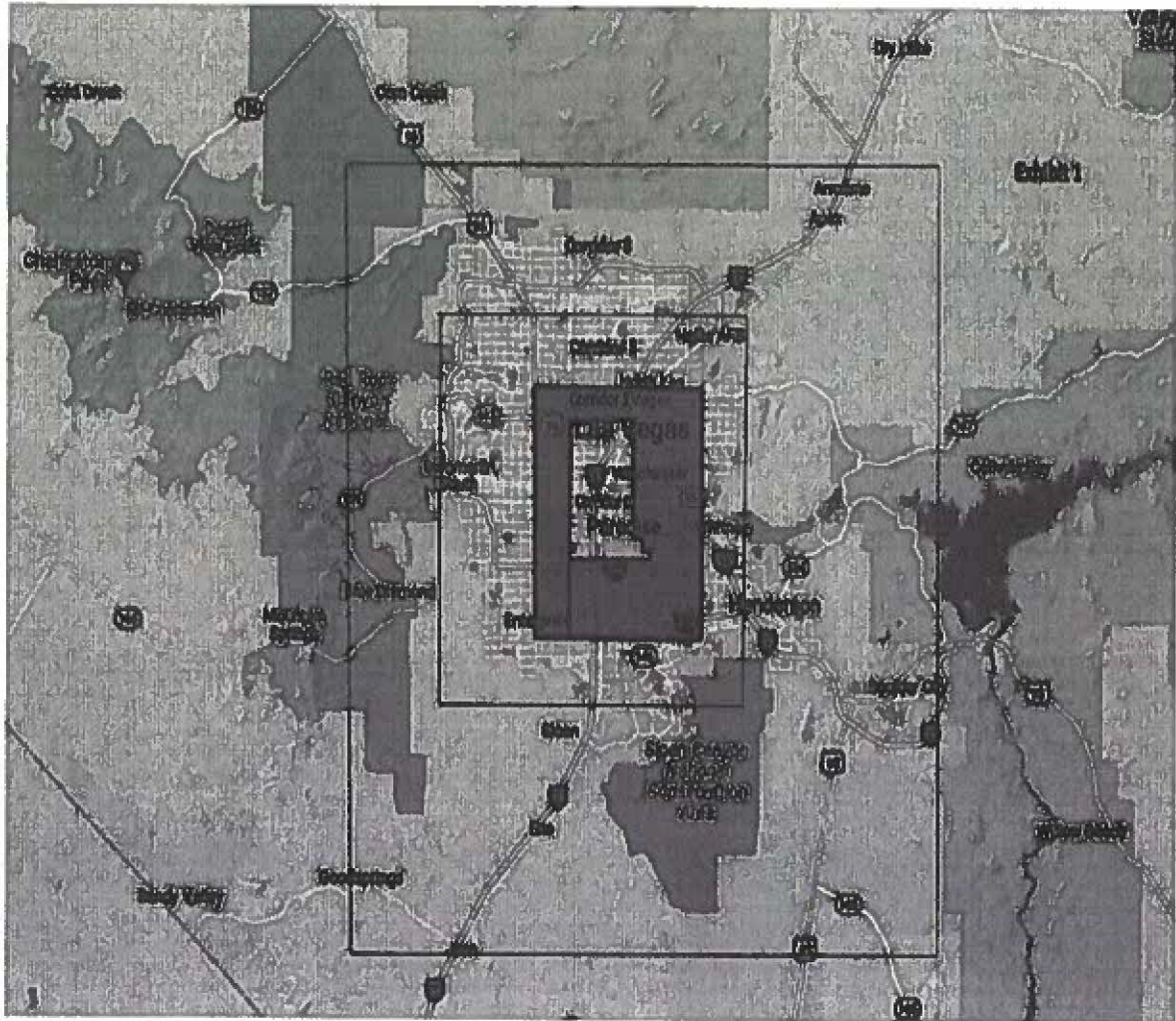
