5 APPLICATION OF TARIFF

Carrier operates scenic tour commercial transportation company, over irregular routes using commercial vehicles to provide intrastate passenger transportation in the form of scenic tours from points and places within Clark County, Nevada, on the one hand, and the State of Nevada on the other.

10 COMPUTATION OF RATES AND CHARGES

Rates and charges are identified herein and pertain specifically for custom tours on an hourly basis consistent with the authorized authority as granted by the Nevada Transportation Authority and per capita charges for scenic tours.

15 BAGGAGE

- a) Hand baggage shall not exceed forty (40) pounds per each bag per adult passenger;
- b) Articles with sharp edges will not be carried unless securely and safely packaged;
- c) Explosives, inflammables, or harmful liquids will not be transported.

25 OBJECTIONABLE PERSONS

Carrier reserves the right to refuse transportation to any person under the influence of intoxicants or drugs, or incapable of taking care of himself or herself, or whose conduct is likely to be objectionable to other passengers.

Exception: Incapacitated or ill persons accompanied by a nurse or guardian.

RULES AND REGULATIONS

30 LIABILITY

Pursuant to NAC 706.333, a claim by a shipper or consignor against a common motor carrier for lost or damaged freight Or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered. Thereafter, within 14 days after receipt of the claim, the carrier shall either: (a) compensate the shipper or consignor; or (b) deliver to the Shipper or consignor a written denial of the chain. A denial of a claim may be appealed by the shipper or consignor to the NTA.

Carrier will not be liable for loss or damage to baggage or their contents, unless such loss or damage is caused by lack of responsible care, and then only for the reasonable value thereof, subject to a maximum liability to \$250.00 for the Loss of, or damage to, any single piece of baggage, including contents.

LIMIT OF LIABILITY

Carrier will not be liable for delays caused by an Act of God, Public Enemies, Authority if Law, Quarantine, Riots, Strikes, Accidents, Breakdowns, Highway Conditions or any other condition beyond its control and does not guarantee arrival or departure time from any given point at any specified time. However, the carrier will endeavor to maintain the schedule submitted by the contracting party but the same is not guaranteed.

If in the opinion of the carrier, an act of God, Public Enemies, Authority of Law, Quarantine, Riots, Strikes, Accidents, Breakdowns, Highway Conditions or any other condition beyond its control, makes it inadvisable to operate its equipment from the point of origin or any point enroute, the carrier shall not be liable therefore or be caused to be held for damages for any reasons whatsoever.

Carrier Tea on the Strip will not be held liable or responsible for personal articles lost, stolen from passengers or left in the equipment/vehicle.

50 CANCELLATION

All cancellation fees and timelines are to be identified by the carrier on each charter contract and adhered to per that contract. Carrier will collect the penalties as outlined on such contracts.

Tea on the Strip, will charge a cancellation fee of 50% of the total amount in the event that the request for transportation is canceled less than 7 days from the time of cancellation notification to the time of requested service. Cancellation with less forty-eight (48) hours' notice will be charged the full amount of the charter order.

The carrier may cancel any service because of weather or other conditions such as road hazards due to slides, storms, or other similar causes, natural, or otherwise which makes travel inadvisable.

Any amenities booked must be prepaid in advance; the customer is responsible for any fees incurred for cancelling any booked amenities (regardless of time frame- i.e. if client requests tickets to a show and then cancels the reservation then they will still be charged for the tickets since that is something that is nonrefundable).

TARIFF RULES

CLARIFICATIONS TO TARIFFS AND FEES:

1. **Minimum Charges:** The minimum charges for custom tours will be two hours.
2. **Additional Fee:** A 2.9% surcharge will be charged to cover credit card, debit card fees
3. **Booking Fee:** A 2.9% booking fee will apply to all ticket purchases through a third party vendor.
4. **Commissions:** The carrier may give a commission to an agent that has arranged the charter for the carrier with a client. Such commission shall not exceed 20% of the total charter rate.
5. **Damages to or in Vehicle:** Any damages caused by any individual on the vehicle, will be charged at cost to the person reserving the service. This could include but, is not limited to: Anything broken, stolen or missing, being left in a dirty state of condition, or any bodily fluids or solids.
6. **Added amenities, not already included with any vehicle, (i.e., flowers, balloons, gifts, beverages, special event tickets, catering, video games, luggage vehicle or car, etc.)** will be charged the rate in which the carrier is charged for per amenity plus a booking fee of \$20.00 per amenity. If staff has to go off premise to pick up amenities there then will be a \$20.00 per hour staff fee as well as the booking fee.
7. **Animals:** Dogs, cats, or other live animals will not be carried unless properly confined in an approved carrier. **EXCEPTION:** seeing-eye dogs in the performance of their duty guiding blind persons.

3% Excise Tax

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1. The passenger transportation recovery charge must be passed along to all customers.

NOTE 2. The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
