FUEL SURCHARGE TABLE AND RULES

The following Fuel Surcharge Rules will apply to carriers who are authorized to provide charter service by limousine and who are authorized to charge and collect a fuel surcharge:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25th calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE). Energy Information Administration (EIA) survey on Weekly Retail Gasoline and Diesel Prices. Regular Grade - West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices. Diesel, All Types - West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA, at (202) 586-8800 or via the DOE, EIA website at www.eia.doe.gov, via the "Petroleum" link.
2. If the 25th day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1st day of the following month and will remain in effect through the last day of that calendar month.
4. The fuel surcharge will be added to an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

The following diesel fuel-related cost price adjustment (surcharge) will apply on charter bus transportation charges, as described below.

1. On the 25th day of each calendar month, the price per gallon of diesel fuel will be determined based on the price stated by the U.S. Department of Energy (DOE), Energy Information Administration's (EIA) survey on "retail On-Highway Diesel Prices-West Coast Average." This price will be obtained by calling the DOE Fuel Hotline at (202) 586-6966 or via the DOE website at www.eia.doe.gov.
2. If the 25th day of the calendar month is a federal holiday, the price will be determined based on the State DOE price available on the subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the diesel fuel price adjustment factor matrix set forth in this item to determine the diesel fuel cost price adjustment that will become applicable on the P¹ day of the month. The adjustment determined will apply for all transportation beginning on the 1st day of the following month and will remain in effect through the last day of that calendar month.
4. The resulting charge is in addition to all other applicable transportation charges.
5. The diesel fuel surcharge, if applicable for a given month, must be passed along to all charters.
6. The diesel fuel cost price adjustment will be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.
