## 5 ANIMALS:

Animals will not be carried unless they are seeing-eye dogs, or dogs performing Assistance for handicapped passenger {s}.

## 10 APPLICATION OF TARIFF:

Rules, regulations, and charges named in this tariff are stated in gross {commissionable} terms; and cover only ground transportation of passengers and their baggage in limousines, including the chauffeur {driver}, as provided in Carrier's Operating Authority.

## 15 BAGGAGE:

Hand baggage not to exceed forty {40} pounds per bag per passenger. Explosives, flammables, or harmful liquids will not be transported. Carrier will not be liable for loss or damage to baggage or their contents thereof unless occasioned by lack of reasonable care on its part and then only for the maximum liability of \$100.00 for the loss of, or damage to, any single piece of baggage, including its contents.

## 20 CANCELLATION FEE:

Carrier reserves the right to change a cancellation fee in the event that the request for transportation is cancelled less than twenty four {24} hours from the time the cancellation notification to the time requested service. This fee shall be the minimum charge for the service originally requested.

## Rule No.

## 25 CHILDREN-UNACCOMPANIED

No person under the age of 18 will be permitted to take part in any service unless a parent, or guardian, or other responsible adult accompanies the minor. We define an adult as any person who is 18 years of age, or older, and who is responsible for the care and supervision of the child {children} during the full length of service. In the event that no adult supervision is available and/or feasible, a signed parental permission for will be required from an adult, parent, and/or guardian to relieve us from any liability.

## 30 CLAIMS

Unless otherwise prescribed by law, all claims whatsoever character must be filed in writing with the carrier within seven {7} days. Within fourteen {14} days after receipt of the claim, the carrier shall:

- A. Either compensate the consignor
- B. Deliver to them a written denial of the claim.
- C. A denial of the claim may be appealed by the claimant to the Nevada Transportation Authority.

## 35 COMPUTATION OF RATES AND CHARGES

Rates and charges proved in this tariff, for services ordered are applicable to waiting time, deadhead live service, and apply from the time the limousine is dispatched until its return to the point of dispatch. Also, charges shall be prepaid or paid by established accounts within thirty {30} days of service. Charges for services in addition to the Services ordered and previously prepaid within twenty four {24} hours of presentation of invoice or transportation bill to the debtor.

## Rule No.

## 40 LIABILITY

The carrier will not be liable for delays or cancellations caused by the act of God, public enemy, acts of terrorism, authority of law, quarantine, riots, strikes, break downs, bad conditions of the road, traffic jams, other conditions beyond its control; and does not guarantee to arrive at or depart from any point at a specified time. The carrier will endeavor to maintain the schedule submitted by its agent or employee; and over routes indicated, but the same is not guaranteed.


If any act of God, public enemy, authority of law, quarantine, peril of navigation, riots, strikes, the hazards or dangers of incident to the state of war, accidents, break downs, bad conditions of the road, traffic jams, and other conditions beyond its control make it, in the opinion of the carrier, inadvisable to operate its equipment either from the point of origin or any point en route, the carrier will not be held liable for damages for any reason{s} whatsoever.

## 45 NON-DISCRIMINATION

Carrier will not refuse service to anyone because of race, creed, sex, or National origin.

## 50 OBJECTIONABLE PERSON(S)

Carrier reserves the right to refuse transportation to any person{s} under the influence of intoxicants, drugs, person incapable of taking care of himself or herself {unless they are incapacitated by illness and are accompanied by a nurse / guardian / care giver, or whose conduct is likely to be objectionable to other passengers or prospective passengers.

## 55 PASSENGER AGENT {S}

Carrier may elect to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively, desire to obtain points for the collection of all applicable charges and remittance thereof direct to carrier without individual passenger fare collection by the carrier.


## 60 REFUNDS

Service requested must be cancelled by booking party with a minimum of twenty four {24} hours in order to receive a full refund. Cancellations with less than twenty four {24} hour notice is nonrefundable.

Furthermore, unless otherwise prescribed by law, carrier reserves the right to refund any charges when service was not provided or completed by any conditions mentioned thereof on the liability Rule No. 40.

## 65 SEAT BELTS

All passengers will be required by law to fasten the vehicle's seat belts at any time the vehicle is in motion. Carrier reserves the right to refuse transportation to anyone who cannot wear a seat belt. Furthermore, passengers {unless otherwise prescribed by law}, releases of any liability whatsoever, when opting to not wear the vehicle's safety belts.

## FUEL SURCHARGE TABLE AND RULES

The following Fuel Surcharge Rules will apply to carriers who are authorized to provide charter service by limousine and who are authorized to charge and collect a fuel surcharge:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25th calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE). Energy Information Administration (EIA) survey on Weekly Retail Gasoline and Diesel prices, Regular Grade - West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types - West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA at (202) 586-8800 or via the DOE, EIA website at [www.eia.doe.gov](http://www.eia.doe.gov) via the "Petroleum" link.
2. If the 25th day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel prices obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1st day of the following month and will remain in effect through the last day of that calendar month.
4. The fuel surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

When the DOE Fuel Price Per Gallon reported on the 25th of the month is:	The Fuel Surcharge that becomes effective on the 1st day of the following month is:

NOTE 1: The fuel surcharge that is applicable for a given month must be passed along to all customers.

NOTE 2: The fuel surcharge must be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.

3% TAX Pursuant to SECTION 51 of AB175

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transferservice.

3. {Intentionally omitted}

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and places in the State. The term does not include charter services by bus, charter Services by limousine, scenic tours, or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
