RULES AND REGULATIONS

APPLICATION OF TARIFF

Fares and charges named in this Tariff are stated in gross(commissionable) terms and cover only ground transportation of passengers and their baggage, as provided in the Carriers Operations Authority in special services operations. Rates and changes are provided in this tariff, for services ordered, shall be paid under the terms agreed upon between customer and the company.

BAGGAGE

Hand Baggage, not to exceed 30 lbs in weight will be carried during the charter services ordered. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to luggage or baggage contented thereof unless occasioned by lack of reasonable care on its part and then only for the maximum liability of \$75.00 for the loss of, or damage to, any single piece of baggage, including its contents.

ANIMALS

Animals, other than "Service" Animals or Companion Animals as defined in the ADA regulations, will not be carried. All service or companion animals must be properly confined and kept under control at all times.

Passenger Agent

Carrier may elect to appoint as its agent any organization, corporation, motel, hotel, or legal gaming operation, who individually or collectively desire to obtain passenger bus transportation service between one or more common points for the collection of all applicable charges & remittance thereof direct to the carrier without individual passenger fare collection by carrier.

Payment terms/Cancellation Policy

Payment is collected in full based upon a predetermined weekly, monthly schedule with parents/guardians. A 12 hour cancellation notice is required to cancel scheduled pickup. At the time of the cancellation, a credit for pickup/delivery will be administered immediately to said account. Cancellation notice release of liability goes for both the patron and GO Vamo due to the following:

A. The carrier will not be liable for delays caused by an Act Of God, public enemies, authority of law, quarantine, perils of navigation, riots, strikes, and hazards i.e. state of war, accidents, breakdowns, bad conditions of the roads, storms and other uncontrollable conditions. The carrier will use best efforts to maintain the scheduled transportation.

B. If any Act of God, public enemies, authority of law, quarantine, perils of navigation, riots, strikes, and hazards or dangers incident to a state of war, accidents, breakdowns, bad conditions of the road, storms, and other conditions beyond its control, make it, in the opinion of Go Vamo transport, inadvisable to operate a vehicle either from the place of origin or any point enroute, the carrier will not be liable

therefore, or be caused to be held for damages for any reason whatsoever.

Fair Minimum

A Minimum of one way fare must be paid to warrant Service.

Special Service Rates and Charges

Special services means transportation of persons who have acquired the exclusive use of a vchicle for a specific itinerary between definite points of origin and destination, at a per capita rate. Special services do not include charter services, scenic tours or airport transfers.

Itinerary & Points of origin and definition shall be within the certified area and further defined pursuant in N.A.C. 706.239.

Fares are per person one way in either direction, roundtrip unless otherwise noted. Special services shall be provided for a non defined number of people based on business level.

Go Vamo Pricing:

*Daily: one way- 14.99- (3 mile radius trip travel)

*Pre purchased Daily Round Trip- 29.00(3 mile radius trip travel)

*Additional Miles beyond 3 mile radius will incur 1.00 per mile.

*Pre purchased Monthly Monday--Friday only -475.00 a month per occupant

*Signature child tracking & app access-(gps location tracking for each child by the parent. Also allowing access to the camera on the vehicle to monitor their child live.---10.00 per child

3% TAX Pursuant to SECTION 51 of AB175

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
