4. Attach evidence of insurance, Form E and/or Form H, with the new domicile location to this petition and label and tab as EXHIBIT 4.

5. If the new domicile is a personal residence and you intend on parking the vehicle(s) at the new domicile, provide: 1) a letter signed by an authorized officer of any homeowners' association that governs the property, and 2) a letter signed by an authorized officer of the city (or county if not within city limits) office of parking and code enforcement where the residence is located. These letters shall attest that business vehicles may be parked lawfully at the residence in furtherance of the motor carrier business. These letters shall also identify the carrier, identify and describe the vehicles at issue, and identify the address of the residence where they will be parked. Attach the supporting letters with the new domicile location to this petition and label and tab as EXHIBIT 5.
6. Attach business license, if applicable, with the new domicile location to this petition and label and tab as EXHIBIT 6. (Does not apply to charter bus or consent-only tow authority.)
