

**INFORMATION AND INSTRUCTIONS REGARDING CHARTER LIMOUSINE
FORM PACKET TO BE USED DURING THE PILOT PROGRAM FOR THE**

2024 SUPER BOWL SPECIAL EVENT

This document outlines the various requirements, deviations/waivers, and procedures required by the “Pilot Program for the 2024 Super Bowl Special Event”

The following documents are part of the “Pilot Program for the 2024 Super Bowl Special Event” Packet:

- a. Two (2) page fillable Application form – this is due to the NTA by December 20, 2023
- b. One (1) page fillable Tariff Request Form – this is due to the NTA by December 20, 2023
- c. One (1) page fillable Master Lease Agreement Form – form and leases due to NTA by February 15, 2024

The two (2) page Application Form must be printed, signed and dated in the required locations.

If the carrier intends to charge a tariff, different from the one(s) presently on file with the NTA, the Tariff form must be completed and submitted **by December 20, 2023**.

An original - containing original signatures - and two (2) copies of Application Form and Tariff Form must be submitted to the NTA by **4:30 p.m. on December 20, 2023**.

Late submission of the Request Form and Tariff Form will not be accepted.

Any required fees – as set out in the Application Form - must be paid at the time the Application Form and Tariff Form are submitted to the NTA.

Deviation/Waiver Requests: Carriers can request one or more deviations from specific portions of NAC 706.208 and NAC 706.210 regarding lease documents and to temporarily add leased vehicles to their fleet for the limited time frame of January 29, 2024 to February 14, 2024.

Each deviation is listed on the "APPLICATION FORM."

Each necessary deviation should be checked. Only one (1) **\$50.00 deviation fee** will be required regardless of the number of requested deviations.

1. Deviation/Waiver Explanations:

- Deviation Request 7(a) applies to carries which will be providing the Authority with the “Master Lease Agreement Log” less than 10 working days before execution of lease to comply with NAC 706.210(2)

- Deviation Request 7(b) applies to carriers which will be leasing vehicles for longer than 14 days - see NAC 706.210(3)(a)
- Deviation Request 7(c) applies to carriers in which more than ½ of the vehicles will be leased vehicles – see NAC 706.210(3)(c)(1)
- Deviation Request 7(d) applies to carrier which lease vehicles and exceed the number of vehicles authorized to operate – see NAC 706.210(3)(c)(2)
- Deviation Request 7(e) applies to carriers which will be submitting a “Master Lease Agreement Log” to comply with NAC 706.210(5)(a) & (b)(1).
- Deviation Request 7(f) permits deviation from providing a complete driver file as required by 49 CFR section 391.51; **STILL required to provide medical examiner certificate [391.43(g)] AND preemployment drug testing [382.301(a)]**

To establish market - at least one of the specific types of documents noted in the Application must be submitted by December 20, 2023.

Failure to submit market documents will result in the immediate rejection of the Pilot Program for 2024 Super Bowl Special Event Packet.

Other Required Information: Regardless of deviations, certain information and documents are still required to be submitted to the NTA – all of the below documents must be submitted **to the NTA by Friday February 2, 2023 at 3:00 pm**

For Charter Limousine – 15 or less passengers including the driver.

Fleet Documents:

1. Fleet List – Excel spreadsheet (**this is a separate document from the Master Lease Agreement Log and will be provided – by NTA Compliance - to each carrier**)
2. A copy of each valid registration
3. US DOT Annual Vehicle inspection
4. Certificate of Insurance and schedule of autos – insurance must list certificated carrier as the certificate holder.
5. Apply for NTA Temporary Limo Decals - \$100.00 each vehicle (NRS 706.465)

Driver Documents:

1. Driver List – part of the Excel spreadsheet
 2. Driver’s License
 3. Medical Examiners Certificate CFR 391.43(g)
 4. Pre-Employment drug test CFR 382.301(a)
 5. NTA Driver Permit
2. The Excel spreadsheet which NTA Compliance will provide - **separately** - to each carrier will establish the required fleet list and list of drivers.
 3. **Responsibility:** Carriers are responsible for ensuring that all leases are in place and available for inspection beginning on February 11, 2024.

Master Lease Agreement Log: A Master Lease Agreement Log is one of the forms included in the Packet. The log must be completed and signed by an authorized manager or officer of the certificated carrier.

The leases must be attached to the Log.

The carrier must submit the Master Lease Agreement Log to the NTA by February 15, 2024.

4. The Master Lease Agreement Log is additional to the Excel spreadsheet which will be provided – **separately** - by NTA Compliance.

5. Vehicles must be inspected by the NTA in order to receive temporary decals.

Please contact NTA Compliance to request a date, time and location for the vehicle inspections to occur. Vehicle inspections must be completed by **Friday February 2, 2024 at 3:00 p.m.**
